Dear Mr. Marby,

I have the pleasure to extend my warm congratulations on your appointment as the President and Chief Executive Officer of the Internet Corporation for Assigned Names and Numbers (ICANN).

Your appointment coincides with an important evolution in the Domain Name System (DNS): the introduction of new generic Top Level Domains (gTLDs); the planned transition of DNS governance and oversight in ICANN's multi-stakeholder model; and ICANN's decision to initiate a policy review of Rights Protection Mechanisms, including the widely relied-upon Uniform Domain Name Dispute Resolution Policy (UDRP).

Comprised of 188 Member States, the World Intellectual Property Organization (WIPO) is the international forum for the development of balanced intellectual property systems. As you would know, WIPO moreover is the globally-recognized leader in the provision of not-for-profit domain name dispute resolution services under the UDRP.

Over time, WIPO and ICANN have positively collaborated to reflect trademark norms in the DNS. This is nowhere more evident than in the recognition of the WIPO-created UDRP as an international policy success for ICANN. More recently, this collaboration was on display in WIPO's successful management of ICANN's new gTLD Legal Rights Objection process.

Some 16 years and 35,000 WIPO cases following its creation for gTLDs and subsequent adoption by numerous country code Top Level Domains (ccTLDs), the UDRP continues to operate for the benefit of all stakeholders, particularly in its harmonized criteria and impartial application of jurisprudence.

My colleagues in WIPO's Arbitration and Mediation Center look forward to continuing to work together with ICANN in preserving the UDRP as an alternative to the courts and a safe harbor for registration authorities.

In these shared goals, I hope to count on your considered support for appropriately reflecting WIPO's unique UDRP expertise and stewardship in ICANN's UDRP review processes, however these take shape.

I am sure that your experience as immediate past Director General of the Swedish Post and Telecom Authority, together with your previous experience as an executive within the technology sector, will serve ICANN and its stakeholders well in this important period.

Finally, as conveyed at the most recent ICANN meeting in Helsinki, Finland, by my colleague Brian Beckham, Head, Internet Dispute Resolution Section, WIPO Arbitration and Mediation Center, I look forward to the possibility of welcoming you personally to WIPO's offices on your next visit to Geneva.
