





A graph will then be generated which shows how many of the relevant applications are at each stage of the process, either 'Data entry', 'Examination', 'Translation', 'Irregular' as well as the notifications coming in the next two weeks.

The following example is for International applications to the European Union.

Please note that the quantity of notifications expected for the next two week are shown on the right side of the graph, and are highlighted below:



You can see here that there are 354 notifications on 07/07/2016 and 503 pm 14/07/2016.

Subsequent designations: status by office of the contracting party of the holder
