## **Madrid Protocol Concerning the International Registration of Marks**

## Individual Fee under Article 8(7): Colombia

- 1. The Government of Colombia has made the declaration referred to in Article 8(7) of the Protocol whereby it wishes to receive an individual fee when Colombia is designated in an international application, in a designation subsequent to an international registration or in respect of the renewal of an international registration designating Colombia (instead of a share in the revenue produced by the supplementary and complementary fees).
- 2. In accordance with Rule 35(2)(b) of the Common Regulations under the Madrid Agreement and Protocol, the Director General of the World Intellectual Property Organization (WIPO) has, after consultation with the Office of Colombia, established the following amounts, in Swiss francs, of the said individual fee:
