IPC REVISION PROGRAM FOR THE 1998-1999 BIENNIUM

When classifying patent document PT 101536 (from the family of document EP0695505) we noted that this document could at a first sight be easily classified under B30B11/00, concerning "Presses specially adapted for forming shaped articles from material in particulate or plastic state", if the classifier was not aware of the existing entry A21C11/00, concerning "Other machines for forming the dough into its final shape before cooking or baking", which includes presses for forming dough pieces.

Of course we could say that an expert probably wouldn't have any doubt. Nevertheless, in cases which are similar, IPC includes after B30B11/00 two references concerning, presses for clay or mixtures containing cement (B28B) and also, presses for plastics (B29). This is done perhaps because IPC is not only to be used by experts but also, by other users.

Thus, we think there are good reasons to give supplemental information to IPC-user adding a further reference after B30B11/00. We note that presses for doughs are spread away for several main groups from A21C, namely 3/00 and 11/00. So, we propose a reference in the following lines:

B30B11/00 Presses specially adapted--- tableting presses (for doughs A21C; for clay or mixtures containing cement B28B; for plastics B29)

The suggested change in the reference note is underlined.

We invite all comments on this proposal by the Colleagues from the other Patent Offices.

IPC REVISION PROGRAM FOR THE 1998-1999 BIENNIUM

Detailed proposal by the Portuguese Patent Office concerning completion of reference notes after the title of subclass F16N which refers to "Lubricating".

F16N is a general subclass and, for that reason, the existing note after the subclass title calls the attention of the IPC-user to several places where we can find specific applications of lubrication. Although we can argue if this list should be exhaustive, it is clear to us, that if there is any note it should be reasonably complete and informative. We believe that the list of references is too much uncompleted and, for that reason we propose several additions which even if they are not exhaustive, certainly can give a better guidance to the IPC-user.
