DIRECTOR GENERAL'S REPORT ON IMPLEMENTATION OF THE DEVELOPMENT AGENDA

Prepared by the Secretariat

- The present document is the second report by the Director General on the implementation of the Development Agenda covering the period from January to December 2010. It is recalled that in keeping with his commitment, the Director General presented his first report on this subject to the Committee on Development and Intellectual Property (CDIP) at its fifth session held from April 26 to 30, 2010.
- 2. This report is structured in three parts: Part I provides an overview of the mainstreaming of the Development Agenda; Part II provides a summary of the Development Agenda Projects and; Part III provides the Outlook for the Future. In addition, Annex I to the document provides an overview of the status of Implementation of recommendations and Annex II provides an overview of the main achievements of the 19 Development Agenda projects that are currently under implementation.

PART I: MAINSTREAMING THE WIPO DEVELOPMENT AGENDA

Development Agenda Mainstreaming into WIPO's Program Activities

- 3. The Program and Budget 2010/11 provides the structural foundation for the integration of the Development Agenda in the work of the Organization. The approach of establishing linkages between the Development Agenda recommendations and the various substantive programs of the Organization which was first introduced in the Revised Program and Budget 2009, was further refined to respond to the evolving trends in the Organization's activities and delivery of services as proposed for the 2010/11 biennium. These linkages, on the one hand, continue to provide guidance as regards the principles and requirements of the Development Agenda and, on the other hand, ensure that the Member States and the Secretariat are able to monitor and evaluate the progress in the implementation of the Development Agenda.
- 4. The Medium Term Strategic Plan (MTSP) of WIPO establishes a pervasive focus on development and seeks to incorporate the 45 Development Agenda recommendations and the principles contained in them in WIPO's work conducted under the nine Strategic Goals. This focus ensures the long term sustainability of the Development Agenda implementation as the future biennial Program and Budget proposals will continue to be guided by this strategic direction.
- 5. As a result of the Development Agenda linkages provided in the Revised Program and Budget 2009, the Program Performance Report (PPR) for the biennium 2008/09 (document A/48/6) contained, for the first time, a section under each Program in which its role and contribution to the implementation of the Development Agenda was reported to Member States. The PPR also contained, as an Annex, a report on the expenditure related to development activities, providing a comparison of actual expenditure with the 2008/2009 revised budget for development activities. While this has been a significant improvement in the assessment of program performance and reporting on the implementation of the Development Agenda, the aim would be to seamlessly integrate the Development Agenda implementation in the Organization's PPR and avoid duplication of efforts while demonstrating clear results.
- 6. As WIPO continues to deepen the integration and mainstreaming of the Development Agenda in its work, under the Development Agenda Project on "Enhancement of WIPO's Results-Based Management (RBM) Framework to Support the Monitoring and Evaluation of Development Activities" (DA_33_38_41_01), a stock taking exercise to review the appropriateness of the current results framework (Program and Budget 2010/2011) as it relates to development and the mainstreaming of development considerations and Development Agenda projects and recommendations was undertaken. This stock taking exercise has provided useful insights as to the areas where the mainstreaming of the Development Agenda could be further strengthened in the Program and Budget 2012/2013. In addition, a macro-level analysis of the status of RBM within the Organization has been conducted. This review resulted in a number of high level recommendations as regards the organizational planning framework for the biennium 2012/2013.
- 7. The Assemblies of the Member States of WIPO in October 2009, requested the Secretariat "to undertake a review of the budgetary process applied to projects proposed by the CDIP for the implementation of the Development Agenda recommendations, with a view to submitting the recommendations of such review to the next regular session of the Program and Budget Committee". Accordingly, the Secretariat undertook a review of the past and current practice of financing and implementing Development Agenda projects and activities within the overall context of WIPO's Program and Budget cycle and a

proposal on the "Budgetary Process applied to Projects proposed by the Committee on Development and Intellectual Property (CDIP) for the Implementation of the Development Agenda Recommendations" was adopted by the WIPO Assembly in September 2010. A key consideration in the above-mentioned review by the Secretariat was to ensure that Development Agenda projects and activities were integrated into the Results Based Management (RBM) framework of the Organization in order to facilitate their monitoring and evaluation within the overall context of program performance.

- 8. A significant achievement during 2010 was the adoption by Member States of the Coordination Mechanisms and Monitoring, Assessing and Reporting modalities. The Mechanism provides additional tools to the CDIP to ensure that development considerations form an integral part of WIPO's work.
- 9. The WIPO Academy training programs significantly contribute to the implementation of the recommendations in Cluster A of the Development Agenda by meeting the training needs of the Member States. In, 2010, the Distance Learning courses offered education and training in IP to over 40,000 participants in 2010 with over 75% attendance from developing countries and LDC. As requested by the Member States, in 2010 a project was initiated to introduce the WIPO Development Agenda in the highly attended distance learning (DL) courses. The so called 'learner-centered-approach' was developed to give higher visibility to the teaching of IP and development. As a result, specific modules are being developed for the General Course on IP (DL-101), Copyright and Related Rights (DL-201), Trademarks, Geographical Indications and Industrial Designs (DL-302) and Patents (DL-301) making the WIPO Development Agenda an integral part of these courses. The first of these modules will be completed in April 2011.
- Following discussions on the Roster of Consultant presented to the third session of the CDIP (Document CDIP/3/2), under Recommendation 6, the structure of the Roster of has been revised to take into account the comments made by Member States. It is recalled that the Roster of Consultants now forms part of the "IP Technical Assistance Database project (IP-TAD)" and is available online. This Roster contains information on consultants engaged by the Organization to undertake specific intellectual property (IP) technical assistance activities at the national level. In view of the laws relating to the privacy of information, consent of individual consultants has been sought and the database is being populated as consents are received.
- 11. Keeping in with the spirit of the Development Agenda recommendations 8, 10, and 11, access to patent information was further enhanced through the indexation of national patent collections that have been included in the Patentscope® platform. National patent collections from Argentina, Morocco, Spain, Colombia, Costa Rica, Guatemala, Panama, Peru and Uruguay were uploaded and indexed in Patentscope. Work also continued on bridging the language barriers for access to patent information included in the PatentScope® platform through the deployment of Cross Lingual Patent Search (CLIR) in PatentScope® covering; German, English, Spanish, French and Japanese. The Chinese, Portuguese and Russian interfaces of PatentScope® have also been developed and are available. Google Translation was integrated to PatentScope® to allow users to easily machine translate descriptions and claims available in text form in PatentScope®.
- 12. Significant cooperation with other inter-governmental organizations (IGOs), particularly in the UN system, continued during 2010. It is recalled that a number of Development Agenda recommendations, notably recommendations 30, and 42 deal with this matter. WIPO's cooperation included both supporting the work of other organizations on issues related to IP (for example, implementation of World Health Organizations (WHO's) Global Strategy and Plan of Action on Public Health, Innovation and Intellectual Property and

providing technical inputs to the United Nations Climate Change Conference (UNFCCC) and Rio plus 20, negotiating processes, the preparatory work for the United Nations Least Developed Countries (UN LDC) IV Conference in Istanbul in May, 2011, and the United Nations General Assembly (UNGA) on WIPO's contribution to accelerating achievement of the Millennium Development Goals (MDGs) as well as exploring collaboration with other Organizations in the implementation of WIPO's programs and activities, particularly in the implementation of the WIPO Development Agenda. To this end in 2010, WIPO entered into cooperation agreements with United Nations Industrial Development Organization (UNIDO), Food and Agricultural Organization (FAO) and European Organization for Nuclear Research (CERN). WIPO also continued to actively participate in meetings regularly organized by various UN agencies and IGOs, namely, World Trade Organization (WTO), World Health Organization (WHO), United Nations Conference on Trade and Development (UNCTAD), United Nations Economic, Science and Cultural Organization (UNESCO), International Telecommunication Union (ITU), Internet Governance Forum (IGF), United Nations Department of Economic and Social Affairs (UNDESA), World Bank (WB), Chief Executive Board (CEB) and High Level Committee Programs (HLCP) in order to ensure better cooperation and benefiting from the complementary expertise of different IGOs. WIPO's work with the WTO has included support for national and regional events, including Regional Workshops on the Least Developed Countries (LDC's) Needs Assessment process and the Global Trade-related Technical Assistance Database (GTAD). WIPO has also engaged in discussions with United Nation Institute for Training and Research (UNITAR) and the ITU with a view to developing a program of collaborative activities. In 2010, WIPO provided contributions to various inter-governmental and UN processes and programs and to request for submissions on a variety of subject matter, for example, from World Summit on the Information Society (WSIS) and the Commission on Science and Technology for Development (CSTD), Economic and Social Council (ECOSOC), WTO, UNCTAD, WB, New Partnership for Africa's Development (NEPAD), Office of the High Commission for Human Rights (HCHR).

- 13. With respect to the MDGs, WIPO made available on its website information on its activities related to supporting the achievement of the MDGs. In addition to providing a contribution to the UN MDG Summit Outcome Document and a note on WIPO's Visually Impaired Persons (VIP) Initiative for a UN report on realizing the MDGs for persons with disabilities.
- 14. Civil Society participation has also been enhanced in several of WIPO's meetings (Recommendation 42). In 2010 the Assemblies of the Member States of WIPO decided to grant observer status to 8 International NGOs and to 6 National NGOs. Moreover, representatives from NGOs have increasingly been invited to participate in a wide range of WIPO activities, including, in particular, activities relating to the WIPO Development Agenda and briefings on WIPO activities. WIPO has also participated actively in meetings organized by other institutions on issues relating to the Development Agenda and welcomes the interest that the issue has raised among a wide range of civil society institutions, including many that have not traditionally participated in WIPO activities.
- 15. Following a request by Member States, a document (CDIP/5/4) addressing five patent-related flexibilities was submitted at the fifth session of the CDIP held from April 26 to 30, 2010. At that session, Member States requested WIPO to extend that work to include other flexibilities. At the sixth session of the CDIP held from November 22 to 26, 2010, while discussing the "Future Work Program on Flexibilities in the Intellectual Property System" (CDIP/6/10), Member States agreed that the following flexibilities be addressed: transition periods left to WTO Member countries in order to implement the TRIPS Agreement; issues related to the patentability of substances existing in nature; disclosure; substantive examination systems; option for countries to adopt the tool of

the ex-officio IP Office control on license contracts in order to avoid anti-competitive practices (CDIP/5/4 Part II). At the same session, the Committee also requested WIPO to undertake certain information dissemination activities, including establishing a webpage on WIPO website; a database containing flexibilities related resources; and organizing meetings at the regional level in order to identify constraints that developing countries and LDCs might face in the implementation of flexibilities at the national level.

Development Agenda Mainstreaming in the work of other WIPO Bodies

- 16. The various WIPO bodies continued to follow the principles laid out by recommendations 15, 17, 21, 22 and 44 of the WIPO Development Agenda. The Agendas and issues to be discussed were established by Member States in the previous sessions of each of those bodies or by the General Assembly. Neutrality continued to be the central principle for the Secretariat while facilitating the work of the various committees and working groups, and negotiations amongst Member States.
- 17. The following paragraphs summarize the ways in which the Development Agenda has been addressed by the various WIPO bodies, inter alia, the norm-setting committees and other committees and working groups.
 - (a) Standing Committee on the Law of Patents (SCP): A number of documents submitted to the 14th and 15th sessions, held from January 25 to 29, 2010, and October 11 to 15, 2010, respectively, as well as the discussions held at those sessions, had direct relevance to the WIPO Development Agenda. In particular, in relation to Recommendation 22, an external experts' study on exclusions from patentable subject matter and exceptions and limitations to the rights (document SCP/15/3), prepared by a group of academic experts, was presented at the 15th session of the SCP. Further, in line with Recommendations 19, 22 and 23, a preliminary study on transfer of technology (document SCP/14/4) was prepared by the Secretariat, and the Committee held substantial discussions on that topic at its 14th and 15th sessions. The Committee agreed that it will continue to work on those topics.
 - (b) Standing Committee on Copyright and Related Rights (SCCR): SCCR continued to hold informal consultations with the participation of experts from all regions to assist in the deliberations of the Committee. During 2010, open-ended informal consultations on limitations and exceptions were organized in Geneva on May 26 and 27, followed by open-ended informal consultations on the protection of audiovisual performances on May 28. Three proposals for normative instruments in the area of exceptions and limitations were submitted at SCCR-20 (SCCR/20/10, 11, and 12). Numerous delegations linked the work towards a possible treaty on limitations and exceptions with Development Agenda objectives. The Committee also continued discussions and implementation of practical measures aimed at providing better access to copyright-protected works by the blind, visually impaired (VIP) and other reading-disabled persons. The work of the VIP stakeholders' platform continued throughout 2010, aimed at developing solutions to make published works available in accessible formats.
 - (c) Standing Committee on the Law of Trademarks, Industrial Designs and Geographical Indications (SCT): SCT has continued to work in a Member-driven manner in line with the Development Agenda recommendations, in particular recommendation 15. For example, during 2010, the SCT agreed on a reference document on grounds for refusal of all types of marks and published it as a reference document in all six official languages (WIPO/STrad/INF/5: Grounds for Refusal of all Types of Marks). Likewise, the SCT agreed to finalize a reference

document on technical and procedural aspects relating to the registration of certification and collective marks and to publish it (WIPO/STrad/INF/6: Technical and Procedural Aspects Relating to the Registration of Certification and Collective Marks). While agreeing to and issuing those documents, the SCT developed a set of references which take into account different levels of development, as well as a balance between costs and benefits. They are the result of a participatory process, which takes into consideration the interests and priorities of all Member States and the viewpoints of other stakeholders, including accredited IGOs and NGOs. Moreover, the SCT conducted an open and balanced consultation in the form of a questionnaire concerning the protection of country names against registration and use as trademarks. The development of that questionnaire was a joint effort by all SCT Members and the results of the questionnaire were presented for further deliberation at the 24th session of the SCT (SCT/24/6).

- (d) The Intergovernmental Committee on Intellectual Property and Genetic Resources, Traditional Knowledge and Folklore (IGC): Under the new mandate provided by the WIPO General Assembly in 2009, the IGC is undertaking "text-based negotiations with the objective of reaching agreement on a text of an international legal instrument (or instruments) which will ensure the effective protection of genetic resources, traditional knowledge and traditional cultural expressions". This is considered to be the strongest mandate the IGC has had to date and the work undertaken by the IGC under its new mandate constitutes important progress towards the implementation of DA recommendation 18. The mandate also makes provision for Intersessional Working Groups (IGWs), to facilitate the IGC's negotiations. The IGC has, always been a Member State-led, inclusive and participatory process, with unique mechanisms specifically to ensure that a broad range of interests and priorities are taken into account. The issues under discussion in the IGC are directly related to economic, cultural and technological development and are of particular interest to developing countries, LDCs and their communities.
- (e) Advisory Committee on Enforcement (ACE): Development Agenda Recommendation 45 guided the work program agreed by the ACE for its sixth session (December 1 to 3, 2010). This work includes a review of methodologies applied in existing studies to measure the economic impact of counterfeiting and piracy; research to identify different types of infractions and motivations for IPR infringements, taking into account social, economic and technological variables and different levels of development; targeted studies with an aim to developing analytical methodologies that measure the social, economic and commercial impact of counterfeiting and piracy on societies, taking into account the diversity of economic and social realities as well as different stages of development; and an analysis of various efforts, alternate models and other possible options from a socio-economic welfare perspective to address the counterfeiting and piracy challenges. During the sixth session of the ACE, delegations expressed views on the contribution of the ACE to the implementation of the WIPO Development Agenda. Those views will be forwarded by the Chair to the 2011 WIPO General Assemblies.
- (f) PCT Working Group: at its third session, held in Geneva from June 14 to 18, 2010, the PCT Working Group discussed a study by the International Bureau entitled "The Need for Improving the Functioning of the PCT System" (PCT/WG/3/2). Part V of that study addressed the issue of how future development of the PCT could be matched with applicable Development Agenda recommendations. In this context, the study explicitly identified those recommendations of the Development Agenda, notably from Clusters A and C, which were considered to be particularly

relevant to the general objectives of the PCT, notably to support technology transfer and technical assistance for developing countries. Based on the study, the PCT Working Group endorsed a series of recommendations covering a variety of actions which should be undertaken by the International Bureau, applicants, Contracting States and national Offices (acting in both their national and international capacities) to make the PCT system more effective both for processing patent applications and for supporting technology transfer and technical assistance for developing countries. The Working Group also commissioned a series of studies to assess how successful the PCT system has been in disseminating technical information, in facilitating access to technology and in providing technical assistance for developing countries. These studies will include recommendations on ways to boost the PCT's performance in these areas and will also explore the possibility of extra-budgetary funding arrangements to finance technical assistance projects. These studies will be discussed by the PCT Working Group at its fourth session in June 2011.

PART II: DEVELOPMENT AGENDA PROJECTS

- 18. In order to enhance efficiency in the implementation of the 45 recommendations and to avoid overlap and duplication, a project-based methodology was adopted by the CDIP held in April 2009. Since the adoption of this methodology, a total of 19 projects addressing 25 Development Agenda recommendations have been approved by Member States. The project on "Conference on Mobilizing Resources for Development" was completed in November 2010, while 18 remaining projects are still under implementation.
- 19. The implementation of the nine projects on technical assistance (Recommendations 2, 5, 8, 9 and 10) presented to the third session of the CDIP and addressing activities that had been decided by the CDIP in April 2008 continued during 2010. In addition, implementation of the following five new projects approved during the third and fourth sessions of the CDIP commenced in January 2010;
 - (a) "Project on Intellectual Property and the Public Domain (Recommendations 16 and 20)";
 - (b) "Project on Intellectual Property and Competition Policy (Recommendations 7, 23 and 32)";
 - (c) "Project on Intellectual Property, Information and Communication Technologies, the Digital Divide and Access to Knowledge (Recommendations 19, 24 and 27)";
 - (d) "Project on Developing Tools for Access to Patent Information (Recommendations 19, 30 and 31)"; and
 - (e) "Project on Enhancement of WIPO's Results-Based Management (RBM) Framework to Support the Monitoring and Evaluation of Development Activities (Recommendations 33, 38 and 41)".
- 20. A progress report on the implementation of the 14 above-mentioned projects was presented to the sixth session of the CDIP (CDIP/6/2). The report complemented the first progress report on the implementation of the nine projects presented to the fourth session of the CDIP (CDIP/4/2), and provided an update on a wide range of activities undertaken in the framework of the Development Agenda projects. Progress reports will continue to be presented in the future under the standing item entitled "Monitor, assess,"

- discuss and report on the implementation of all adopted Development Agenda recommendations".
- 21. In addition to the above-mentioned projects under implementation, the fifth and sixth sessions of CDIP held in April and November 2010 respectively also approved another five new projects, namely:
 - (a) "Project on Intellectual Property and Product Branding for Business Development in Developing Countries and Least-Developed Countries (LDCs) (Recommendations 4 and 10)";
 - (b) "Project on Capacity Building in the Use of Appropriate Technology-Specific Technical and Scientific Information as a Solution for Identified Development Challenges (Recommendations 19, 30 and 31)";
 - (c) "Project on Intellectual Property and Socio-Economic Development (Recommendations 35 and 37)";
 - (d) "Intellectual Property and Technology Transfer: Common Challenges Building Solutions (Recommendations 19, 25, 26 and 28)";
 - (e) "Open Collaborative Projects and IP-Based Models (Recommendations 36)".
- 22. The implementation of the first three above-mentioned projects approved during the fifth session of the CDIP started in May 2010, while the implementation of the two remaining projects approved in the sixth session of the CDIP commenced in January 2011.
- 23. A brief description of the approved Development Agenda projects together with the status of their implementation as well as their main achievements and outputs are provided in Annex II. The following paragraphs highlight a few achievements made under the Development Agenda project.
 - a) The project to implement recommendation 5 on "IP Technical Assistance Database (IP-TAD)" (DA_05_01) has been completed. The post-implementation stage is currently seeing some additional value-added enhancements being made to the system to cater to the internal needs of WIPO, in particular the uploading of information related to technical assistance activities during the planning stages and the monitoring of technical assistance activities throughout their life-cycle. This will provide the WIPO management with valuable information during the planning and implementation stages of their work programs.
 - b) Under the project "Specialized Databases' Access and Support" (DA_08_01), the Access to Specialized Patent Information (ASPI) program was initiated in 2010. This program provides access to flagship patent database services from Dialog, LexisNexis, Minesoft, Questel, Thomson Reuters, and WIPS to 115 developing and least developed countries. In addition, 107 developing and least developed countries continues to benefit form the Access to Research for Development and Innovation (aRDi) program launched in 2009 in cooperation with 12 major Publishing companies. Also, six national networks of Technology and Innovation Support Centers (TISCs) were launched, and three regional conferences for Africa, Asia, and Certain Eastern European and Central Asian Countries were organized in 2010, to promote access to and effective use of technology databases and foster an exchange of best practices in providing technology information services.

- c) The Development Agenda project for the "Establishment of Start-up National IP Academies" (DA_10_01) has attracted considerable attention of the WIPO Member States. Between May and December, 2010, eleven countries requested WIPO's assistance for the creation of their national IP Academies. As a result, five *ad-hoc* consultants have been requested to assist in the implementation of individual projects. Seven fact-finding missions have been held, and the project is currently in the feasibility study phase in eight countries, and four other countries are foreseen to start feasibility phase in the first semester of 2011.
- d) A project paper was developed under the project "Innovation and Technology Transfer Support Structure for National Institutions" (DA_10_03). This paper was reviewed by two external experts: one NGO and one Government consultant. The external experts refined the document and identified some necessary elements that were included to complete the project paper. As stage two, the 55-page project paper was posted on WIPO website inviting comments of the Member States. The current stage of the project involves the development of the first prototype of the Digital Portal, for which some of the contents and tools have already been identified.
- e) A series of benchmarking tools have been developed under the project on "Improvement of National, Sub Regional and Regional IP Institutional and User Capacity" (DA_10_05) with a view to assisting officials involved in the development of national IP strategies in assessing the status of their national IP system, defining strategic targets and assessing specific IP needs. Testing and validation of this methodology is well underway in the Dominican Republic, Mongolia and Moldova. Initial feedback from these pilot countries has led to the refining and strengthening of the project methodology and of the project tools. This improved methodology will be further tested and consolidated in three additional pilot countries namely Mali, Tanzania and Algeria in 2011.
- f) Under the component "strengthen regional/sub-regional IP institutions by providing assistance for the establishment of sub-regional cooperation mechanisms" of the project on "Improvement of National, Sub Regional and Regional IP Institutional and User Capacity" (DA_10_05), two resolutions supporting the establishment of i) a Caribbean Regional Patent System and ii) a framework for the protection of Traditional Knowledge (TK) were adopted by a WIPO ministerial meeting in Grenada. A series of national consultations were subsequently held with all the Member States of the Caribbean Community (CARICOM) with a view to gathering inputs from the legal, academic and business communities on the establishment of the Caribbean Regional Patent System and presenting a joint position to the Council for Trade and Economic Development (COTED) in 2011. Similarly, a series of consultations and workshops on TK protection were held in 2010, during which it was decided to develop a policy paper on the issue, which will serve as the basis for drafting the framework for the protection of TK in the region in 2011.
- g) Under the component, IP and SME's, of the project on "Improvement of National, Sub Regional and Regional IP Institutional and User Capacity" (DA_10_05), a series of tools have been developed with a view to assessing the needs and challenges of SMEs in effectively utilizing the IP system and identifying strategy options and policy responses to address such needs. The testing of the methodology is underway or in some cases has been completed in six countries namely Brazil, India, Jordan, Poland, South Africa and Tanzania. In parallel, WIPO has successfully organized five-day Training of Trainers Programs on effective IP Asset Management by SME's in several of those countries. The objective of the

intensive training program is to build the capacity of trainers to foster IP management competencies amongst SME's in their respective countries. The training programs have been carried out in conjunction with the customization and/or translation of four IP for Business Series publications and adaptation of IP Panorama – a multi media learning tool on IP management – in French and Spanish languages.

- h) Under the project on "Intellectual Property and Public domain", a Scoping Study on Copyright and Related Rights and the Public Domain (DA_16_20_01) was prepared by an external expert and presented by the author during the discussion of the progress report projects in the sixth session of the CDIP. In addition, a master consultant was identified and a number of regional reporters were selected to prepare a study on misappropriation of signs through a fact-based comparative analysis of the trademark laws of a representative number of Member States. A study on patents and the public domain was commissioned to external experts from different continents, who began preparation of the study in 2010.
- i) In the context of the "Development Agenda Project for IP and Competition Policy" (DA_07_23_32_01) two symposia on IP and Competition Policy were organized in Geneva in the context of the project on IP and Competition, and a Study on the relationship between national IP and competition agencies has been completed and will be shortly made available to its Member States.
- j) In the context of the project on "Developing Tools for Access to Patent Information" (DA_19_30_01) five Patent Landscape Reports (PLRs) on vaccines, atanavizir, ritonavir, solar cooking and solar cooling have been contracted and are in the process of being completed. An overall strategy for the production of the e-tutorial has also been agreed and established.
- k) Nine sectoral RBM workshops were also held under the RBM projects (DA_33_38_41_01) focusing on improving the results frameworks for the Program and Budget 2012/13, and enhancing the mainstreaming of Development Agenda recommendations and projects. Draft terms of reference (ToRs) for the external review of WIPO's technical assistance were circulated to Member States in July 2010. The revised ToRs incorporating the comments received from Member States were subsequently posted on the WIPO website under the project with the reference CDIP/4/8/Rev/TOR. The external review is currently ongoing.
- 24. In addition to the above-mentioned approved projects, a revised version of the project on "Patents and the Public Domain" (addressing Recommendations 16 and 20), discussed during the sixth session of the CDIP, and taking into account comments made by delegations will be considered by the current session of the Committee. Also, a new project on "Intellectual Property and Brain Drain" (addressing Recommendation 39), and taking into account the Discussion Paper presented to the fifth session of the CDIP as well as the comments on the Discussion Paper made by delegations will be considered during this session. As WIPO Member States continue to take keen interest in the Development Agenda process, a project proposal from the Arab Republic of Egypt on Enhancing Cooperation on IP and Development among Developing Countries and LDCs will also be considered by the current session of the committee.
- 25. The estimated financial resources devoted to the implementation of the 19 approved Development Agenda projects amounts to 21,921,000 Swiss francs.

PART III: OUTLOOK FOR THE FUTURE

- 26. Tangible progress has been achieved so far in the implementation of the Development Agenda which can be categorized in two broad areas of work. The first relates to the establishment and adaptation of institutional mechanisms geared to facilitate an enhanced mainstreaming of the Development Agenda in the work of the Organization. This work will continue as we prepare to develop the Program and Budget for 2012/13 and successive biennia and seek to enhance the efficiency of the Organization's Results Based Management framework.
- 27. The second area pertains to the implementation of the Development Agenda recommendations through specific projects and regular activities of the various WIPO programs which are fully informed by the principles embedded in the Development Agenda recommendations. A number of the Development Agenda Projects will come to completion in 2012. The outcome of these projects will feed into the future activities of the Organization as some of the follow-up activities will be undertaken within the regular activities of the Organization and some others may require follow-up projects. The Secretariat, in particular the Development Agenda Coordination Division (DACD) will continue to facilitate discussions in the CDIP and other relevant bodies as regards the continual implementation of the Development Agenda recommendations.
- 28. In order for the WIPO Member States to derive benefits from the Development Agenda implementation WIPO continues to assist countries in devising appropriate plans and policies, in particular, in developing National IP Strategies under Strategic Goal III Facilitating Use of IP for Development. WIPO encourages its Member States to fully integrate IP into their national development policies and in doing so, benefit from the range of the Development Agenda projects and other activities of the Organization which suits their development objectives.
- 29. The Organization will also continue to facilitate the Member State discussions in other WIPO bodies in particular those dealing with the future norm-setting with the view to fully integrate the Development Agenda principles in the future work of the Organization. In this endeavor, the Organization will be guided by the principles of neutrality, transparency, accountability and a result oriented and development friendly culture consistent with the Organization's Strategic Realignment Program (SRP) and the Medium Term Strategic Plan (MTSP).
