WHAT IS SPORT?

- UNICEF emphasized incorporating sport into country programmes to help "disadvantaged children develop a healthy lifestyle and increase cohesion with their community"
- IOC has called for greater access to sports for girls and women, people with disabilities and marginalized communities as sport and physical activity are major contributors to a healthy lifestyle

THE POTENTIAL OF SPORT AS A TOOL OF DIPLOMACY

- The international landscape of the world of sport also presents a host of ideas to draw on in serving as a tool of diplomacy
- Some examples "Ping Pong" diplomacy between the US and China in the 1970s; 2010 FIFA Football World Cup in Africa and the Olympic Truce

THE IMPORTANT ROLE SPORT PLAYS IN MILLIONS OF DAY TO DAY LIVES

- Sports for All promotes the Olympic ideal that sport is a human right for all individuals regardless of race, social class and gender
- Most countries have various high participation and Sports for All programmes in addition to high performance programmes for elite athletes
