 - decisive for the high quality of patents
- since 2008 all products and processes related to the search and examination
 - ⇒ certified in line with the standard ISO 9001:2015

Quality Management System ISO 9001:2015






Patents: Application Procedure

Patent Department

3 divisions

- Chemistry
- Mechanics and Electricity
- Technology

35 patent examiners

- patent applications
- utility model applications

Junior examiners

⇒ trained by the appointed senior examiner
for 2 years



Patent Application Procerure

Filing/Receiving of Application

⇒ Patent Information Dept.

- Preliminary Examination
- Substantive Examination
- Decision on Application
- Patent Revocation



⇒ Patent Dept.



Filing/Receiving of the Application

- Filing Registration
 - checked the constitutive requirements of patent application
- Bibliographic Data Registration
 - entered into electronic registration system (SyPP)
- Scanning of documents
- Filing Fee the payment checked
- Assignment of applications to respective examiners in the patent department to further proceed with the examination
 - done by the particular senior examiner using the basic IPC level



Preliminary Examination

- Examination of formal requirements
 - power of attorney, right to a patent, etc.
- Preparation of the application for publication
 - Classification of the subject-matter (IPC + CPC)
 - Examination of specification (mainly changes in abstract)
- Publication of patent application
 - 18 months from the priority date



Substantive Examination

- on request
- within 36 months from the filing date ⇒ deferred examination
- examination fee paid
- main actions:
 - Search
 - Examination
 - Communication to the applicant
 - Decision



Search

- aim ⇒ finding of the relevant state of art
- search tools ⇒ electronic means:
 - EPOQUENET (the PCT search minimum documentation + non-patent literature)
 - STN
 - MEDLINE, ELSEVIER, EMBASE, IEEE, PUBCHEM (non-patent literature)
 - online national database
- search strategy ⇒ combination of classification (IPC + CPC) and relevant key words
- outcome ⇒ search report
 - \Rightarrow prepared by junior ex. \rightarrow checked by senior ex. \rightarrow head of section
 - ⇒ prepared by senior examiner → checked by head of section



Examination

- assessment of patentability requirements
 - subject matter
 - novelty
 - inventive step
 - industrial applicability
- sufficiency of disclosure
- formal requirements checked
- outcome ⇒ examination report (more than 1 if necessary)
 - ⇒ prepared by junior ex. → checked by senior examiner → checked by head of section
 - ⇒ prepared by senior examiner → checked by head of section



Third party observations

- filed by any person after the publication of a patent application
- the person do not become a party of the patent application procedure
- the patent applicant is informed of any observations submitted
- submitted observations are analysed by the examiner and if relevant considered within the substantive examination
- conclusion of analysis ⇒ checked by the senior ex. / head of section



Decisions on Patent Application

- decisions issued
 - **× refusal of application** (⇒ substantive requirements not fulfilled)
 - **★ termination of procedure** (⇒ formal defects not removed)
 - **y** grant of patent (⇒ substantive and formal requirements met)
- decisions can be appealed
- outcome ⇒ decision
 - ⇒ prepared by junior ex. → checked by senior examiner → checked by head of section (both positive and negative)
 - ⇒ prepared by senior examiner → checked by head of section



Post-Grant Procedures

- patent revocation
- declaratory judgement
- decision ⇒ prepared by the senior examiner (other than the one decided on the application) together with the head of section and signed by the director of patent department

random check of selected patent files – twice per year – performed by the director of patent department
