

One application filed at the European Patent Office or the African Regional Intellectual Property Organization is counted as one application abroad if the applicant does not reside in a respective member state, or as one resident application and one application abroad if the applicant resides in a respective member state.

(9) Both national and regional data are used to establish the list of countries relating to non-resident filings.
