



## **REQUEST FOR THE RECORDING OF A LIMITATION**

## IMPORTANT

- 1. You can request the recording of a limitation for **one** international registration **per form**.
- 2. The request must relate to only **some** of the designs covered by the international registration. If the request concerns all designs covered by the international registration, use form DM/5 (renunciation).
- 3. The limitation to the designs can only be recorded for the **same** designated Contracting Parties.
- 4. All fields are mandatory unless indicated otherwise.
- 5. Complete this form electronically; WIPO cannot accept handwritten forms.
- 6. Avoid printing and scanning this form. Upload the completed and signed form directly to WIPO through Contact Hague.
- 7. For more information on the request for the recording of a limitation, refer to the Guide to the Hague System.
