General terms of contract and trade

§ 1 Legal basis:

The international Patent Application has been published in the International Patent Application Reports, which are edited by the WIPO-World Intellectual Property Organization. This publishing forms the basis of our offer. Accepting the offer your international patent application and/or the company-referring data of the Patent Application holder is stored.

§ 2 Purpose of the registration:

The purpose of the registration is for one thing to be able to obtain by the access to our data files fast information about foreign claims for international patent applications as well as their holders. So you can eventually improve your position in competition. Secondly, it is the purpose of registration to improve eventually your communication possibilities in competition. To fulfill this task or make it easier our data banks with International Patent Applications besides entries about their holders are at your disposal which are enlargenend, actualized and eventually also modified from day to day. The entitled to benefit person has in principle cost-free access to our data bases.
