General Terms of Contract and Trade

§ 1 Legal basis:

The International Patent Application has been published in the International Patent Application Reports, which are edited by the WIPO-World Intellectual Property Organization. This publishing forms the basis of our offer. Accepting the offer, your international patent application is stored, and/or the company-referring data of the Patent Application holder.

§ 2 Purpose of the registration:

The purpose of the registration is for one to be able to obtain access to our data files for fast information about international patent applications as well as their holders, so you can eventually improve your position in competition. Secondly, it is the purpose of registration to improve your communication possibilities in competition. To fulfill this task or make it easier, our data banks with international patent applications, besides entries about their holders, are at your disposal which are enlarged, actualized, and eventually also modified from day to day. The entitled to benefit person has in principle cost-free access to our data base. This is the case not only for our data base in the immediate context of international patent applications of third parties, but also especially referring to our database, in particular to our database in the context of Community Trademarks, International Trademarks, and European Patents.
