Subject : MCD Error and Warning Reports

The EPO proposes to produce information on a regular basis about errors and warnings which have been generated when loading documents into the MCD. Two different files per office will be produced, one for errors and one for warnings. The files will be in the form of delimited text files. The list of fields which the files will contain is shown in Appendix 1.

Files will be posted on the WIPO website, and access will be restricted so that offices can only retrieve their own files.

Symbols generating errors are not stored in the MCD. Warning messages are for information only, and do not prevent symbols from being stored. Errors for a particular document are kept until a new set of symbols is supplied for that document. Warnings are kept for a period of three months.

Appendix 2 shows the list of possible error and warning messages.

Appendix 2 - List of possible messages

- E001** - IPC symbol invalid - symbol does not exist
- E002** - IPC symbol invalid - symbol not valid on given date
- E003** - Unrecognisable date encountered
- E035** - (Reclassification) Original / Reclassified data not 'R', or 'D', IPC not loaded
- E051** - IPC 'R' symbol sent which is not part of any revision project, symbol dropped

- W004** - Classification Level incorrect, value from Validity File taken
- W005** - Version Indicator incorrect, value from Validity File taken
- W006** - First/Later indicator invalid, indicator left blank
- W007** - Classification value invalid, defaulted to 'N' (indexing code) or 'I' (the rest)
- W008** - Indexing code not allowed as invention information, changed to 'N'
- W009** - No invention information provided
- W010** - Action date empty, or invalid, set to publication date
- W011** - Original/Reclass indicator not 'B', 'R', 'V' or 'D', defaulted to 'B'
- W012** - Original/Reclass indicator 'R' provided as new publication data in front file
- W013** - Source indicator not 'H', 'M' or 'G', defaulted to 'H'
- W014** - Generating office not provided, set to CC of Publication ID
- W015** - IPC symbol already supplied for the same publication, duplicate dropped
- W036** - 'D' symbol cannot be found in MCD
- W042** - Reclassification not part of the revision project being processed
- W044** - Reclassification changed all family inventive information to non-inventive
- W048** - Additional information delivered as first classification - First/Later set to 'L'
- W049** - First/late 'F' provided is inconsistent with other symbols, defaulted to 'L'
- W051** - IPC 'R' or 'D' Symbol sent which is not part of any revision project
