1. How does your office understand the term "quality of patents"?

The term "quality of patents" is understood as a quality of patent procedures and management, which include qualitative search, examination and proper control of issued decisions.

In fact, in the process of carrying out the examination, Kyrgyzpatent uses the results of search (and the examination if needed) of the Federal Institute of Industrial Property of Russian Federation with the order of Kyrgyzpatent, but at the same time the experts of Kyrgyzpatent are obliged to carry out an independent search and examination in accordance with the patent legislation of the Kyrgyz Republic.

- 2. What types of cooperation with other patent offices does your office have with respect to search and examination?
 - Kyrgyzpatent uses the services of the Federal Institute of Industrial Property (FIIP) in the field of search and examination on the basis of "The Agreement on carrying out patent search and examination on applications for Inventions and Industrial Designs within scientific and technical cooperation between Scientific-Research Institute of the state patent examination and Patent management at the State Committee on science and new technologies of the Kyrgyz Republic" signed on September 2, 1993. Patent search and examination are conducted on the basis of orders sent by Kyrgyzpatent to FIIP.
 - On the basis of the "Agreement between the Government of the Kyrgyz Republic and the Government of the Russian Federation in the field of Industrial Designs" of October 13, 1995 Kyrgyzpatent has access to the FIIP information retrieval system through passwords provided by Rospatent.

- Kyrgyzpatent has free access to the EAPATIS System of the Eurasian Patent Organization. Access through passwords provided by the Eurasian Patent Organization according to the "Agreement on use of the Eurasian patent and information system between the Eurasian Patent Office of the Eurasian Patent Organization and the State Agency on Science and IP under the Government of the Kyrgyz Republic" of October 6,2003.
