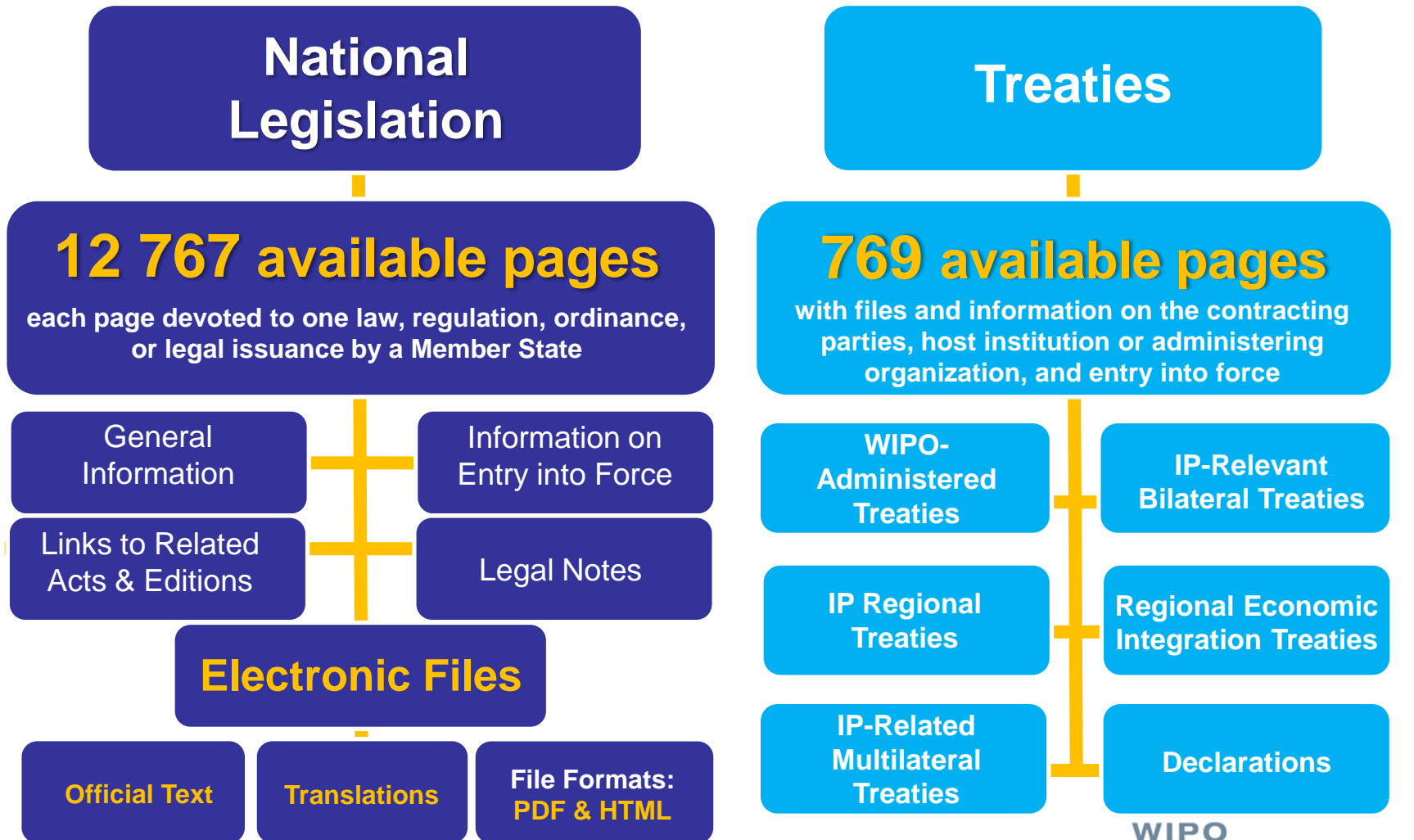

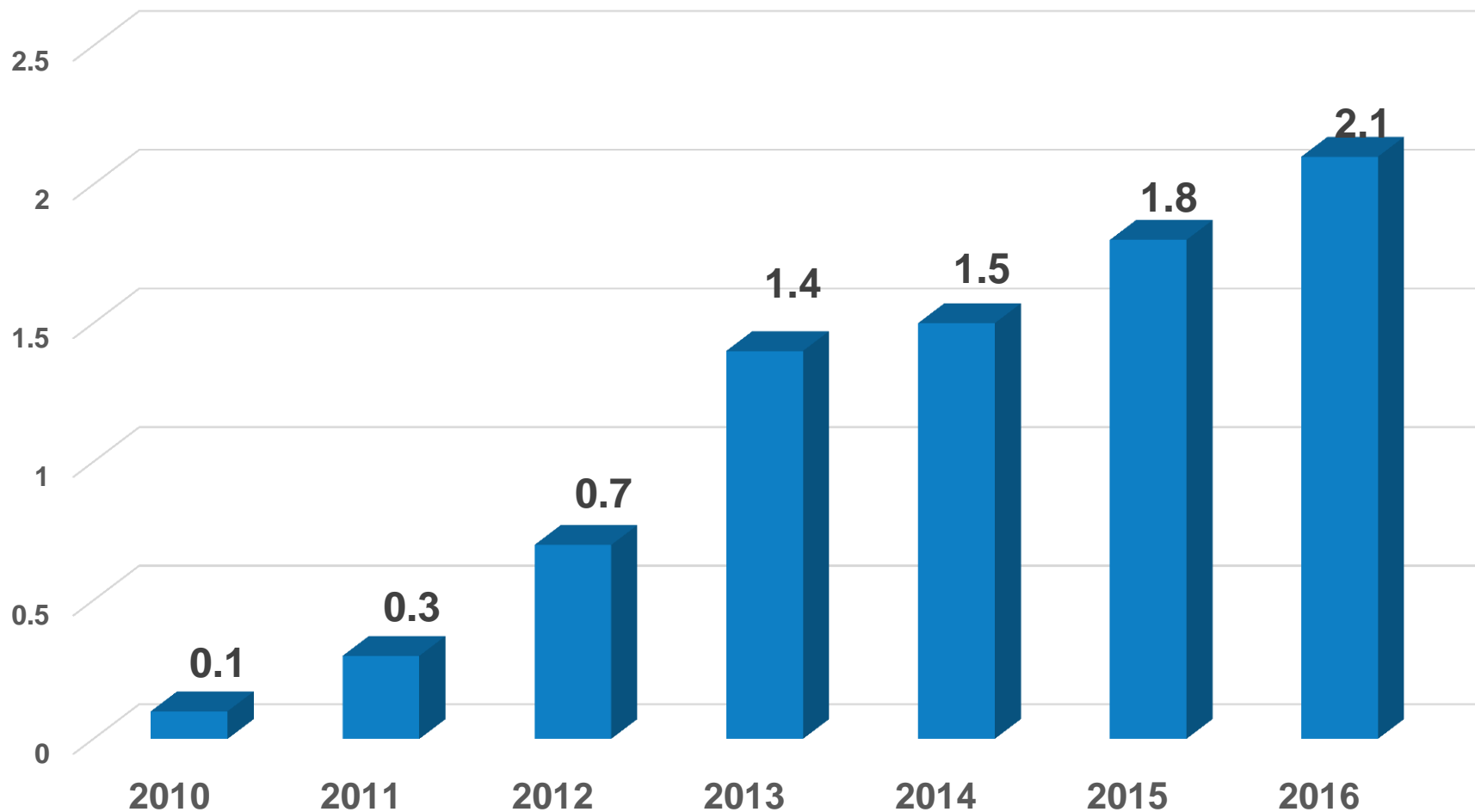

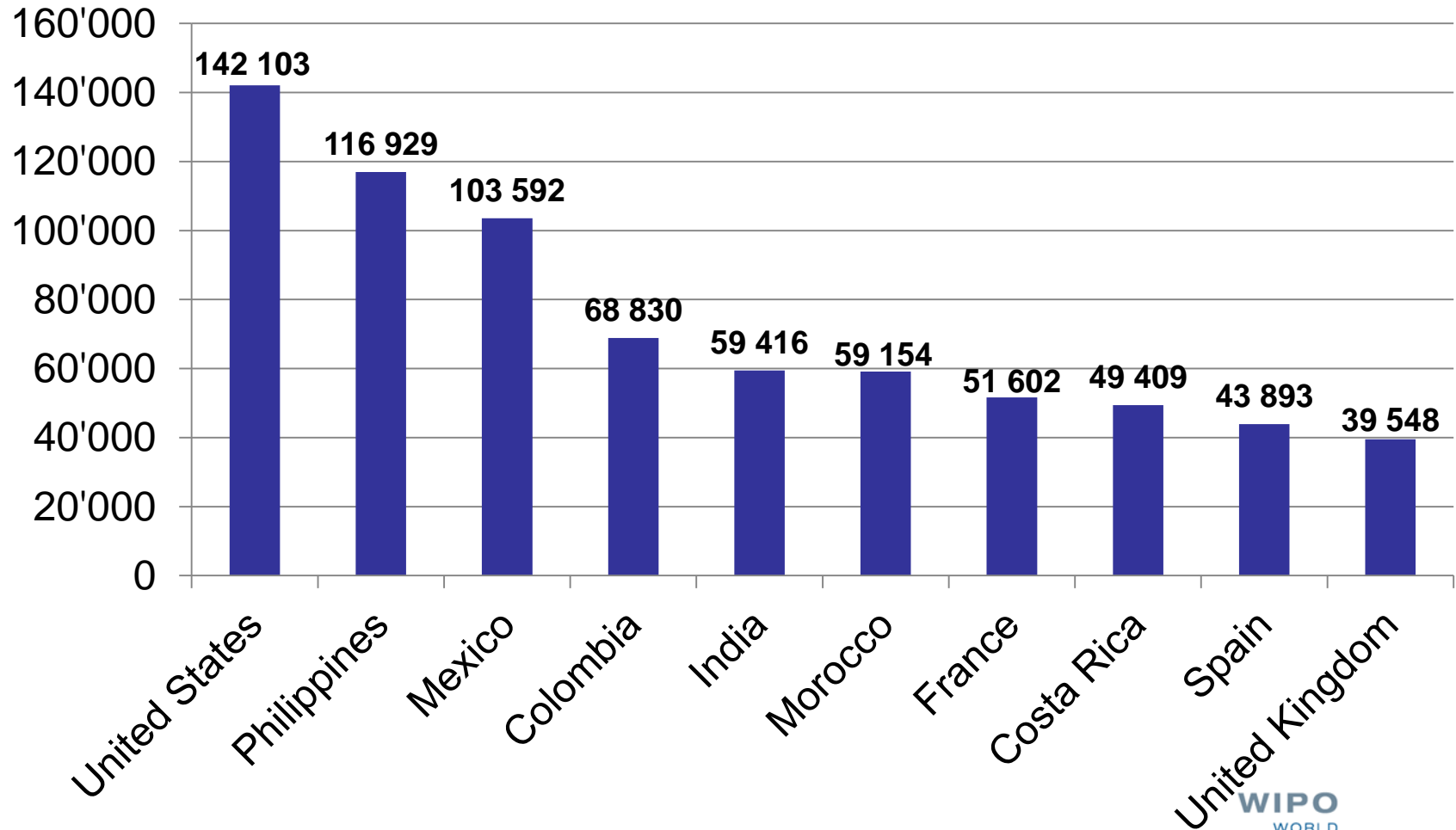
Annual Users (Millions)

*The Federal Assembly of the Swiss Confederation,
on the basis of Articles 31^{bis} paragraphs 2, 64 and 64^{bis} of the Federal Constitution^{1,2}
and having considered the Dispatch of the Federal Council dated 19 June 1989³,
decrees:*

First Title: Subject-Matter

Art. 1

¹ This Act regulates:

- a. the protection of authors of literary and artistic works;
- b. the protection of performers, producers of phonograms and audiovisual fixations and broadcasting organisations;
