Key insights

- Intangible investment in India reached USD 78.2 billion in 2023.
- In the last year (2022–2023), intangible investment grew at 7.9 percent while tangible investment grew at 7 percent.
- Over the past decade for which data are available (2013–2023), intangible investment in India grew at a real rate of 5.3 percent per year, compared to 7.8 percent recorded for tangible investment.
- Intangible investment in India makes up 10 percent of GDP in 2023, while tangible investment makes up 19.3 percent.
- India's fastest-growing intangible asset type was new financial products, growing at 9.7 percent between 2013–2023 in real terms, followed by software & databases (8.2 percent) and brands (7.2 percent).
- Investment in software & databases makes up the largest share (45 percent) of India's total intangible investment in 2023, followed by organizational capital (22 percent) and research & development (R&D) (13 percent).
- 42.1 percent of India's total intangible investment goes unmeasured in official statistics, as of 2023.

Share of GDP, 2011–2023

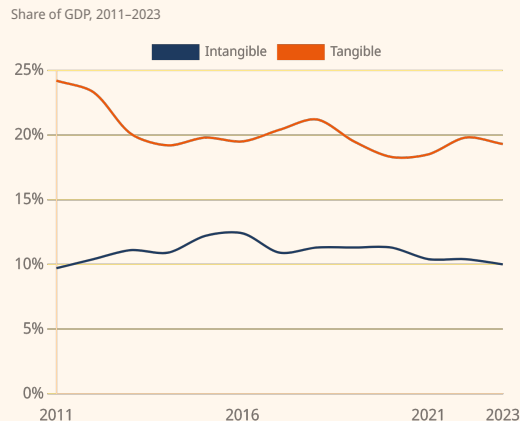


Figure 2: Intangible versus tangible investment growth (India)
Indexed 2013 = 100, latest 10-year period available

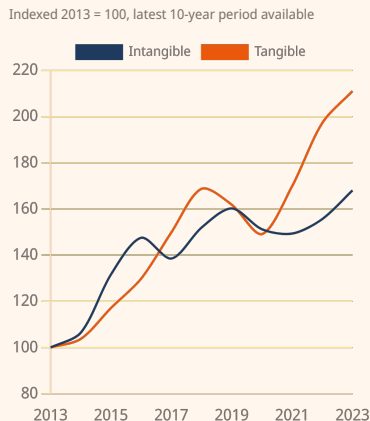


Figure 3: Real growth of intangible & tangible investment (India)
10-year CAGR, 2013–2023

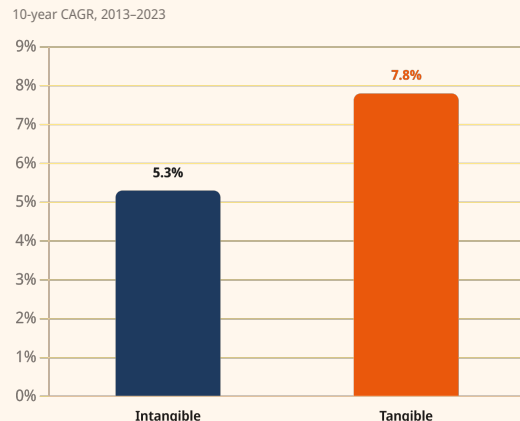


Figure 4: Real growth by asset type (India)
10-year CAGR, 2013–2023

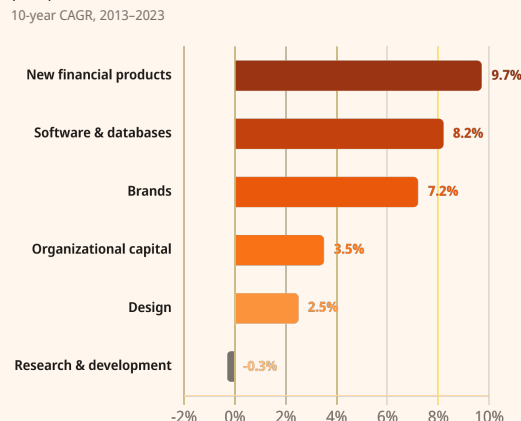


Figure 5: Intangible asset composition (India)
Share of intangible investment, 2023

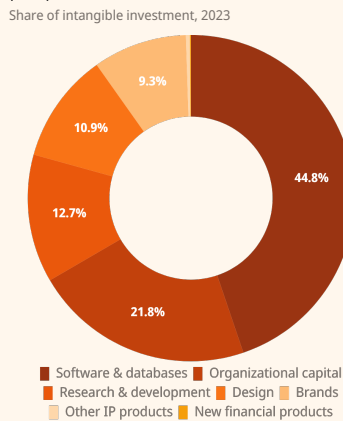
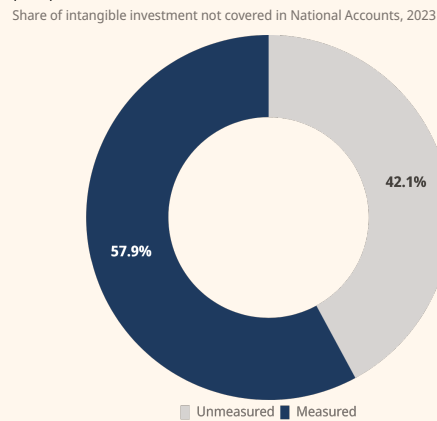


Figure 6: Measured versus unmeasured intangible investment (India)

Absolute levels, latest available year for all countries (2025), except JP (2024) — in USD billions

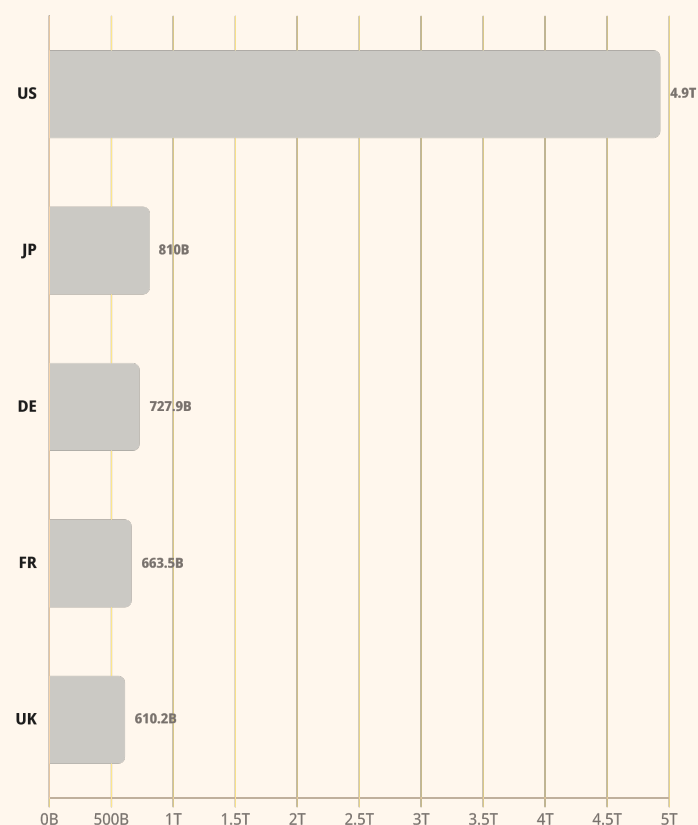


Figure 8: Remaining economies by intangible investment

Absolute levels, latest available year for all countries (2025), except BR (2023), CA (2024), IND (2023), and PHL (2022) — in USD billions

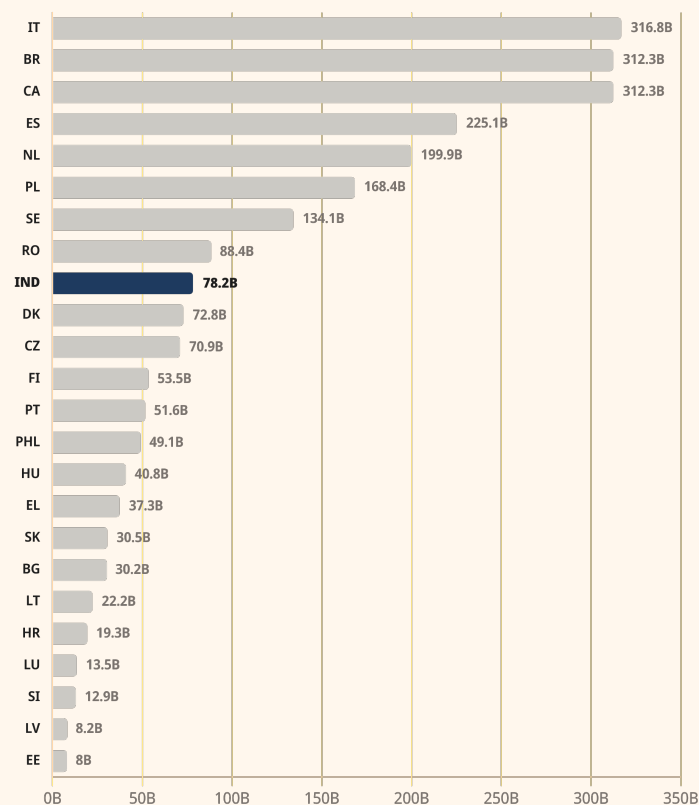


Figure 9: Intangible investment intensity

Share of GDP, latest available year

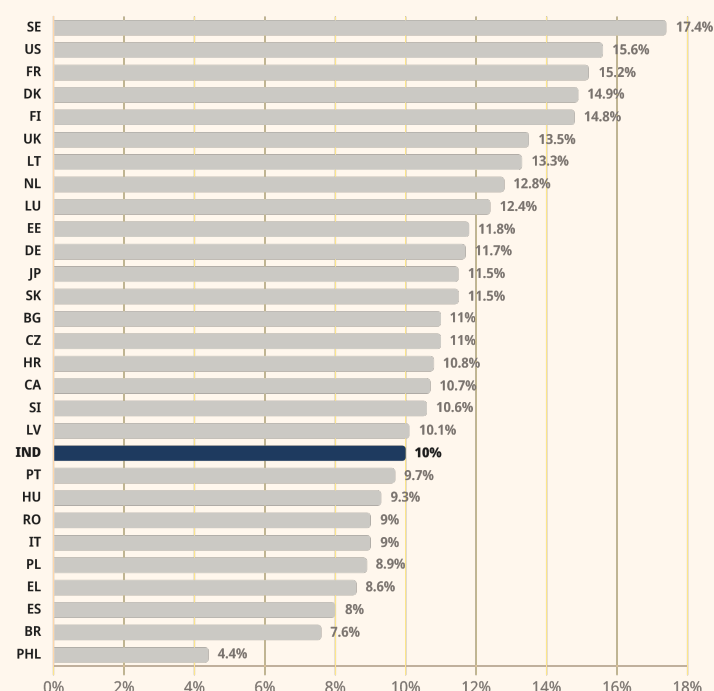
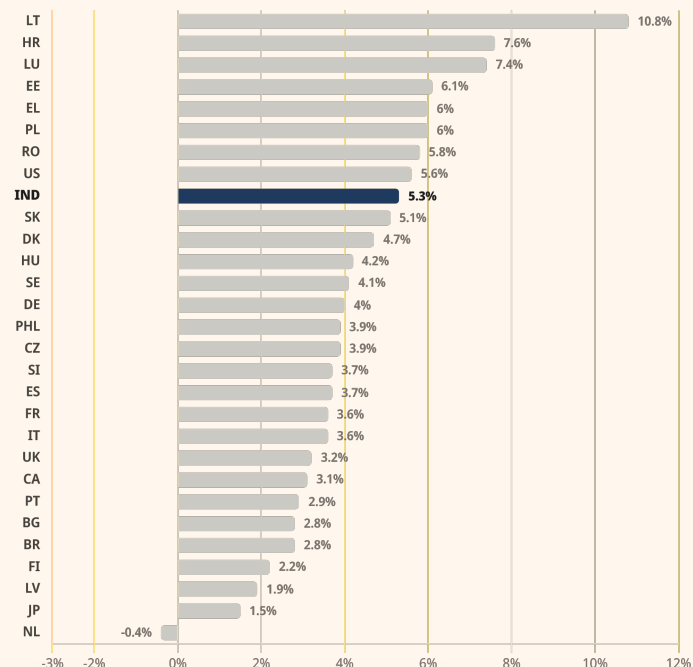


Figure 10: Real growth of intangible investment

Notes: All estimates are based on the most recent data available—2025 for all economies, with the exception of Brazil (2023), Canada (2024), India (2023), Japan (2024) and the Philippines (2022). All investment levels are expressed in purchasing power parity-adjusted current prices. Compound annual growth rates (CAGRs) in Figures 3, 4 and 10 are computed using investment data in chain-linked volume terms to reflect real growth. In general, investment intensities in Figures 1 and 9 are measured as a share of GDP, where GDP is proxied by “adjusted” value-added i.e. taking into account the full set of intangibles. In Figures 1 and 9, the share for India is based on formal sector GDP only; comparable estimates for Brazil and the Philippines are not yet available and are under development for future editions. Figure 4 excludes the “other IP products” category due to gaps in the time-series from 2013 to 2016.
