## Support for more transaction types in the package-data DTD for the Applicant-Office sector

It is IP Australia's intention to use the WAD and WASP standards nationally for electronic filing and further for all electronic exchange (across all transmission sectors) and expect that other Offices may be considering or planning the same. To enable the use of these standards flexibility needs to be introduced that allows for varying transaction models. Currently the standard restricts the transaction model by limiting the nature of applicant to office sector transactions to 'new-application' and 'subsequent-filing' only.

The "package-data" DTD does not allow for support of generic national transactions. The draft ST.36 specifies that the "package-data" DTD shall not be modified for national use. It is IP Australia's proposal that the transmittal-info element allow office specific elements.

To support national transactions IP Australia would add the 'au-applicant-to-office' element as an office-specific element to transmittal-info:

National transactions would include but not be limited to national phase entry, trade mark and designs applications, national patent applications and renewals.

Consideration has been made to limit the impact of the proposed change so that any existing software supporting the current package-data dtd would not require modification.

#### ANNEX 2/ANNEXE

#### Comment by US, EP and JP / Commentaires de US, EP et JP

The United States Patent and Trademark Office, the European Patent Office, and the Japan Patent Office have agreed that PCT/EF/PFC04/003 should be rejected, for the following reasons:

- 1. Annex F was designed only for patent processing in the context of the PCT, not for trademarks or other IP types ;
- 2. package-data.dtd is part of the core technology for e-filing and should not be modified for national use to avoid limiting potential interoperability of patent electronic filing systems;
- 3. package-data.dtd already includes markup for submissions subsequent to initial filing;
- 4. There is an international forum that is creating XML for Trademarks to which the PCT Electronic Filing community should defer with respect to this question.
