Quality Management System for International Search and Preliminary Examination consist basically of three components:

1. Quality standards for Search & Examination work: tools, systems, documented information, training, communication.
2. Quality Assurance: peer review, management review and quality control.
3. Quality review process.

The quality standards and practices are compliance with the standards and practices established by the PCT guidelines. Although the QMS in place is based upon ISO 9001:2015 principles, INPI/BR is not ISO 9001 certified.

The establishment of an internal Quality Assurance System for international search reports (ISR), written opinion (WOISA) and international preliminary examination reports (IPER) is set to assure compliance with PCT and Regulations, PCT administrative instructions, PCT International Search and Preliminary Examination guidelines, and other INPI internal guidelines and instructions.

Since 2022, INPI is in the process of planning and implementation of an automation solution (BPMS – Business Process Management Suite) for the Patent and PCT macroprocesses through the adoption of the business process management discipline and the acquisition of an automated system in order to improve efficiency, effectiveness and quality of its processes. The provider of this system was hired in 2024 and BPMS implementation will be gradual and should take place in the medium and long term, expected to end at the end of 2026.

In 2023, INPI has initiated the journey to implement a new [reference](#) model to improve and achieve excellence in INPI Management, that was part of INPI's 2023 and 2024 Action Plan and INPI's Strategic Plan 2023-2026. This [reference](#) is called Management Excellence Model® (MEG). MEG is a Brazilian Quality Model developed by the National Quality Foundation (FNQ) based on the Malcom Baldrige National Quality Award and others international models. This model aims to stimulate and support organizations in the country in the development and evolution of their management, so that they become sustainable, cooperative and generate value for society and other interested parties. It is based on 7 fundamentals of Excellence [Commitment, Responsibility, Leadership, Systemic thinking, Processes, Innovation and Culture](#). And from the perspectives of 7 results (qualitative and quantitative indicators): economic-financial, environmental, social, customers and market, people, suppliers and products and processes. An organization is considered excellent when it meets in a balanced way, to all de fundamentals of Excellence and the results generated by them.

With the aim of knowing its adherence to this model, in 2023 INPI hired FNQ to perform a diagnosis on its maturity level. In 2024, INPI is giving continuity in MEG's implementation according to an action plan in order to achieve a higher score. The following activities were done: collect and consolidation of evidences to improve management maturity level and hiring of the second cycle of assisted self-assessment in order to obtain a new diagnosis of Management Maturity Level.

## 1. LEADERSHIP AND POLICY

(a) The INPI/BR Quality Policy, available in INPI's web portal (<https://www.gov.br/inpi/en>), more specifically in (<https://www.gov.br/inpi/en/governance/quality>) is:

1. To deliver services efficiently, in a timely manner and in accordance with the standards set by law and by international agreements and treaties.

2. Provide systems to maintain a continuous and efficient contact with its users, analyzing their expectations, assessing their level of perception and dealing with any complaints received to ensure maximum satisfaction.

3. To train and enhance its staff to fulfill the institutional objectives through the sharing of knowledge, harnessing the expertise of each and assuming shared responsibility for the performance and achievement of goals.

4. Be in line with best management and governance practices.

The Quality Policy is used to establish the quality objectives and goals which are periodically evaluated and reviewed by INPI President and the [Internal Governance Committee \(CGI\)](#).

(b) The INPI/BR is headed by a President, an Executive Director and three others Directors, appointed in accordance with Brazilian law. Appointments to positions in committee, roles and functions are made in accordance with current legislation.

The Quality General Coordinator is the responsible to implement and maintain the QMS across the organization. The Coordinator acts as support to management on all levels to ensure the proper function of the QMS.

The Executive Board is represented by the Internal Governance Committee (CGI), the highest level Committee of governance, management of integrity, strategic planning, de-bureaucracy, monitoring and evaluation, and risk management within the Institute. In addition to other competencies, the committee is responsible for institutionalizing the strategic planning process of INPI; establish strategic guidelines, objectives, initiatives and indicators; to monitor the implementation and evaluate the results of the actions planned; periodically review the institutional strategy; undertake actions to find the means and resources sufficient and necessary to execute and sustain the projects related to the institutional strategy; to establish, at its discretion, subcommittees or working groups for advisory subjects of its competence.


In the Patent Board there is a formal Quality Group which is responsible to define and implement QMS under the Coordination of the Quality General Coordination including but not limited to the following activities: to create and implement procedures, manuals, work instructions, supervise its implementation and communication, provide training of related personnel as well the implementation of quality examination review process. This group is also responsible for others activities of the Quality Management System (QMS) required by PCT and Regulations, Administrative Instructions, Receiving Office (RO) Guidelines, and PCT Search and Examination Guidelines.

(a) The QMS is applied by a Quality Group in Patent Board, which are responsible for carrying out the quality management system requirements and the quality review process.

The Working Groups of the areas under the PCT meet regularly with the top management in order to measure the effectiveness of the Quality Review process. These meetings serve as a basis for measuring, analyzing and interpreting the results of the examinations, updating guidelines, procedures and work instructions, detecting whether the user's needs are being met and identifying the points of possible improvements in the quality of services provided.

The Quality General Coordination has the responsibility to conduct customer's survey to detect if their expectations and satisfaction are met. An improvement plan is done with the survey results.

(b) INPI/BR seeks to continually improve the effectiveness of the QMS through a variety of mechanisms, including:

- defining and revising quality objectives,
- measuring quality objectives against minimum performance undertakings,
- measuring customer's satisfaction,
- performing corrective and preventive actions,
- conducting management reviews,
- complying with the quality policy statement,
- reviewing documented information periodically,
- providing periodic training of the personnel,
- applying the risk and process approaches.

In March 2022, INPI started a pilot project to fill out the ISA/IPEA forms directly in the ePCT in XML format, with a small number of examiners (21). After the end of the pilot project and the necessary adaptations, on March 1<sup>st</sup>, 2023 the ePCT became the only tool used by all examiners to fill out the forms for the PCT international phase.

The Internal Governance Committee (CGI), is the highest level Committee of governance, management of integrity, strategic planning, de-bureaucracy, monitoring and evaluation, and risk management within the Institute. It has consultative and deliberative function. In addition to other competencies, the committee is responsible for institutionalizing the strategic planning process of INPI; establish strategic guidelines, objectives, initiatives and indicators; to lead and institutionalize governance structures, strategy, integrity, risks, quality management and internal controls appropriate to the development of the continuous improvement, to promote the integration of risk management into the strategic planning and business process management at all levels of the Institute, to monitor the implementation and evaluate the results of the actions planned; periodically review the institutional strategy and the Quality Management System; undertake actions to find the means and resources sufficient and necessary to execute and sustain the projects related to the institutional strategy; to establish, at its discretion, subcommittees or working groups for advisory subjects of its competence.

The main decision and corrective actions decided by the Committee are spread-out towards the respective managers and processes may be reviewed.

(a) The QMS is continuously monitored by the Quality General Coordination and through the Quality Group and PCT Coordination.

(b)-(c) The extent of compliance of search and examination work with the PCT Guidelines is based on the review of work from the Examiners prior to issue the reports, and also on the review of work sampled after publication. There is a specific and trained group of Patent examiners available to work with PCT (ISA&IPEA) processes. The review findings are reported to the Examiner and to the head of the technical division of their respective examination unit. Reports are regularly provided to the Patent Managers – General Coordinators and Quality Coordination on the extent to which work complies with INPI Quality Standards. Internal quality audits are planned to be carried out on the processes used to ensure their compliance with INPI/BR Quality Management System, Chapter 21 and the PCT Guidelines and other internal regulations.

(d) – (e) At the end of each year, CQUAL meets with PCT management to review and discuss about the reports submitted to WIPO and subjects related to QMS. This review assesses how well the system is performing, what can be improved and whether it is meeting the policy and objectives set for it.

Due to the strong Brazilian legislation, INPI/BR must be in compliance with Risk Management process and, therefore, regularly promotes practices to ensure that risks and opportunities that can affect its QMS and the conformity of international search and examination are addressed. Item 2 describes how INPI/BR handles Risk Management.

## 2. RISK-BASED PRACTICES


*21.14 Explanatory note: All processes of the QMS present differing levels of risk in terms of the Authority's ability to meet its objectives, and the effects of uncertainty are not the same for all Authorities. Each Authority is responsible for the actions it decides to take to address risks and opportunities.*

To provide a better understanding on the issues that affect INPI to achieve intended results and objectives of the QMS, the Risk Management Division from the Quality General Coordination of INPI is periodically offering advices, materials and training on INPI's Risk Management Manual and Database to the patent examiners involved at the PCT's process as well as to others INPI's units and interested parties. All the risks mapped in PCT and QMS process, as well other processes, are recorded and monitored on a database called AGATHA provided by the Ministry of [Planning](#) with the purpose to manage and control the risks identified in the process. Additionally, regular meetings are conducted with INPI units to provide guidance and support on risk management issues. It's also adopted the practice to keep in touch with several offices to understand their challenges and implemented solutions, exchanging knowledge and experiences. In 2022 it was developed and launched with the partnership of another governmental organization, a Business Intelligence tool to help the top management, managers and risk owners in the process of monitoring all INPI's risks and action plans. This BI tool is being periodically optimized and can be accessed through the INPI's internal company network.



The picture below shows an overview of one of the dashboards with a general view of INPI's risks spread in all INPI's macroprocess:



In order to understand the needs and expectations of INPI units and interested parties, we collect some relevant information conducting user satisfaction surveys, holding meetings with interested parties and also from the inputs we receive from ours online users service channels.

To identify risks and opportunities related to the performance of the QMS as a basis for planning, training programs in risk management and process mapping are provided on regular basis, as well as periodicals process reviews and its redesign (if necessary), in order to identify, analyze and valuing risks.

INPI's risk documentation guidelines are composed by the Risk Management Manual and Policy. The methodology to manage risks is defined in the Risk Management Manual. The methodology has as its basic premise the risk assessment within the organizational processes, and is supported by guidelines of the ABNT NBR ISO 31000:2018 standard.

According to this methodology, process owners evaluate the risks, by identifying consequence/probability matrix, in order to establish a risk level. Next, they define responses to risks and, eventually, establish control measures, aiming to modify the level of risks, always seeking to reduce them. Once these actions are properly approved by the risk managers and top management, they are included in the institutional risk database (AGATHA), and the action plan is monitored by the Risk Management Division and by the Committee in order to check its effectiveness.

At any time, risk managers can review any information on risks' database or through the BI tool mentioned above as part of the monitoring process and in order to check whether the actions are being effective as well there are any changes in the context or process related to the risk. As mentioned in item 21.08 there is also an advisory and deliberative forum, the Internal Governance Committee in charge of the leadership and supervision of the most critical risk management and internal controls implementation as well as other assignments.

INPI adopts "The Three Lines" model, where the process owner is the first line of defense in risk management, the Risk Management Division and the Internal Governance Committee are the second line of defense, and the Internal Audit is the third.

Each of these three "lines" plays a distinct role within the organization's wider governance framework, aiming to check the effectiveness of the actions taken.

The risks and opportunities are considered during the strategic and corporate plan and also a context issues analysis is conduct (which includes an updated SWOT analysis) in every new risk management process to ensure a continuously update risks and opportunities.

Risk Management Process adopted by INPI is described below:



### 3. RESOURCES

INPI/BR is constantly providing resources needed to deliver desired outcomes including the maintenance and improvement of the quality management system.

The current staff (technical and administrative) is adequate to deal with the inflow of work and deliver the search and examination process in the established deadlines.

Some regular actions are described as bellow:

- ✓ providing training in industrial property and in foreign languages;
- ✓ graduating masters and doctors at the INPI/BR Academy of Industrial Property;
- ✓ training team leaders,
- ✓ flexible conditions of work for examiners who are in view of obtaining the Doctor title;
- ✓ improved facilities and material resources;
- ✓ deployment of new IT systems to support the examination and administrative service;
- ✓ teleworking (home office) modality: Currently there is a total of 274 patent examiners teleworking. The goal is a productivity average of 130% for the participants in the full teleworking and 120% of partial teleworking respectively 30% and 20% higher than examiners not in teleworking working where it is expected a productivity of 100%, The examiners achieved an average examination productivity of 144,3% in 2024 for the full teleworking program and 130,8% for the partial program. This increase was very positive for INPI exam production results and customers satisfaction.

#### (i) Patent Examiners

- ✓ As a minimum requirement for recruitment, all patent examiners must possess the title of Master of Science and have English or Spanish language skills. As soon as they are selected, they immediately enter professional training courses in specific skills tests. After ~6 months of training, the examiners start to exercise examination procedures, training "on the job" mentoring for ~18 months. The patent examiners also participate in the exercise of technical courses and events in their specific fields, promoted by INPI/BR or by other

entities, for purposes of technical improvement in their areas. Currently, approximately 65% of examiners have the title of Doctor of Science.

- ✓ Among the applied requirements for receiving documentation, referenced in Rule 34, INPI/BR can receive PCT applications in three different languages, which are Portuguese, English and Spanish.

#### Administrative Staff

- ✓ The administrative staff is trained to conduct formal examinations and international administrative procedures of the PCT, as well as to control, verify and registration of applications filed under the PCT.

(ii) Appropriate equipment and facilities such as IT hardware and software to support the search and examination process are provided and maintained. As mentioned in the Introduction of this report, a new System (BPMS) is being developed to improve the process efficiency and effectiveness enabling the automation of different tasks currently performed manually including performance measurement and management activities reducing significantly manual interventions and workload.

#### *Material resources:*

(iii-iv) The INPI/BR often reviews facilities and technological resources. Such review includes:

- ✓ acquisition of new computers with up-to-date common setup, workstation and chairs to accommodate the new examiners. Updating software for basic usage, extension of contracts on patent search databases and developing software resources for online control of all work and registration of examinations, including statistical data, information, issuing forms, and quality indicators. The workstations have electronic dictionaries and translators specifically to work in technical support.
- ✓ hiring of a new System (BPMS) as mentioned in the Introduction of this report. Currently, patents flow (including national patents) uses 14 integrated systems to support search and examination process and the implementation of BPMS aims to incorporate 7 systems inside BPMS suite and to enable integration with 7 remaining systems enabling information and data centralization in one place and making the information up to date and available in all systems. This system will also enable to manage requests for international search and international preliminary examination, assignment of examiners, deadline's controls and several others functionalities.
- ✓ The minimum documentation, referenced in Rule 34, is available, accessible and kept ready for search and examination purposes. All documentation is now stored on electronic media.
- Each examiner work with 2 monitors and has access to the Internet and to search databases such

as EpoqueNet (EPO); STNext (Chemical Abstracts Service – CAS); IEEEExplore (IEEE, through EBSCO BRASIL); Derwent Innovation (Clarivate Analytics LLC), including Global Patent Data, DWPI, CPI Manual Codes and INSPEC; and Sequence Base, including GENESEQ (Clarivate Analytics LLC).

(v) The basic procedures of service relating to the PCT, as the Treaty, the Regulations and Guidelines are available in English and Treaty and the Regulations translated into Portuguese, in both printed and electronic formats, and are released on the occasion of trainings conducted. All the forms and templates for the Search and Examination are automatically available in the patent system (SISCAP) in the three supported languages (Portuguese, English and Spanish).

As part of QMS maintenance, in 2024 PCT Coordination has kept the amount of 83 processes flow developed with the partnership of an external consultancy, 117 work instructions, 2 procedures and 21 forms regarding activities from the receiving office, international search and preliminary examination processes. All these documents were widely communicated and the patent examiners involved with PCT processes were trained.

Patent Examiners that have been trained in the procedures of the PCT in a more extensive work, participate in mentoring, discussing questions and guiding in the most difficulty cases.

Work instructions and procedures are reviewed within maximum three years and whenever necessary, new procedures and work instructions are developed in order to ensure greater consistency and adherence to customers' need and to obtain more efficiency.

*Training resources:*

(vi) The INPI/BR maintains regularly training for examiners, searching and examination procedures, among others. The need, frequency and content of these training programs are reviewed annually in the Annual Training Program.

INPI/BR has a Training Center equipped with classrooms for training new and current examiners. All classrooms have computers so that the examiners can access INPI/BR Search Data Bases and simulate examination. INPI/BR has an integrated communication platform (AVAYA) to enable distance trainings and meetings and there's also the possibility to use others videoconference platforms (such as Zoom, Google Meets, etc).

By regular trainings and speeches the examiners are kept aware of the importance to be compliance with exams criteria and quality standards.

Besides the regular trainings INPI/BR is currently seeking for partnerships with other IP Offices worldwide in order to share best practices and experiences.

*Oversight over resources:*

(vii) Requests for international search and international preliminary examination under the PCT are recorded and controlled through an internal electronic system – SISCAP. Each new request is identified and updated constantly. The SISCAP system informs automatically the deadline for submission of reports, ensuring the proper demand for services.

The head of each technical division, which acts as examiner supervisor, assigns the request to a ISA/IPEA examiner. The examiner is responsible to monitor the deadline and to issue the examination report. After the examination and the peer review, when necessary, the report is sent to the supervisor for substantive verification. After supervisor performs the verification, the report is then sent to PCT division for a final quality inspection. If reports are compliance with standards, they are sent to applicant and WIPO. If not, the PCT division returns back the report with the problem found requesting the examiner to correct it. Only after all quality standards are met, the request is sent to applicants.

#### **4. MANAGEMENT OF ADMINISTRATIVE WORKLOAD**

(i) Requests for international search and international preliminary examination are monitored by the internal electronic system: SISCAP.

The SISCAP system has an automatic mechanism that shows the time remaining to issue the reports, on the registration page or handling of this request.

After completing the forms in ePCT, the examiner uploads a copy of them to SISCAP, which continues to be the system responsible for managing the examiners' workload and for forwarding them to the formal and technical quality review.

(ii) The PCT General Coordinator and the Head of PCT Division are responsible for monitoring and controlling the application fluctuations and possible delays.

#### **5. QUALITY ASSURANCE**

(i-iii) INPI/BR established an internal Quality Assurance System for international search reports (ISR), written opinion (WOISA), and international preliminary examination reports (IPER) involving the evaluation of administrative work in RO, verification of compliance with PCT administrative instructions, PCT Reception Office (RO), Guidelines, PCT International Search and Preliminary Examination Guidelines and other INPI internal guidelines and instructions.

The quality assurance system establishes the following steps of verification at ISA and IPEA stages:

1. **Self-checking by examiner:** when conducting the examination, the examiner fills out checklists for each international application covering the steps at the ISA and IPEA stages. The examiner is responsible to monitor the deadline and to submit the examination report to the supervisor for substantive verification.

2. **Verification of substantive examination:** The Heads of the technical divisions verify the reports issued by the examiners that mainly cover subjects related to the search and patentability requirements, before issuing the ISR and the WOISA. After supervisor performs the quality check, the request is then sent to PCT division for formal quality inspection.

A new search strategy review process has been adopted since 2020, when the examiner finds only documents of the general state of the art (only "A" documents). This process includes the figure of a "partner searcher" who will check the search strategy established by the first examiner and, if necessary, make changes to the strategy and a new research. Thus, with the interaction between the two examiners, there has been an increase in the quality and confidence of the totally positive reports issued.

3. **Formality examination checking:** The PCT division staff performs a formality checking on all PCT forms (100%) to be sent to the applicant and IB, inspecting the integrity and consistency of the details in the forms. If reports are compliance with quality standards, the reports are sent to applicants and WIPO. If not, the PCT division returns back the report with the non-conformity found requesting for change. Only after all quality standards are met that the request is sent to applicants.

In 2023, the PCT Coordination began a pilot project to review the quality of the examination of PCT applications in which INPI acted as International Authority (ISA and IPEA). This review is based on a sample calculated according to the annual batch of ISA and IPEA reports for the period under analysis. The sampling is based on ISO 5426:1985 requirements. [The batch of products eligible for review was composed of the final product delivered by INPI as International Authority after its submission to the applicant.](#) In addition to this new procedure, product quality criteria for ISR and IPER reports were also developed, as well as forms for recording review results. [These criteria were distributed in 3 Categories according to the severity of non-conformity. Each Category is composed of criteria that is subdivided in attributes. As a result, 9 criteria related to the PCT application exam were addressed in the form with 41 objective questions \(attributes\), aimed at exam compliance, published work instructions, PCT Rules and Articles and the Guide.](#) This pilot was ended in 2024 with the report containing the review results and indication of opportunities for improvement in the process and procedures [according the reviewers feedback.](#)

To implement this new post-delivery product quality review procedure, the development of an automation system is underway to carry out the quality review process more efficiently. The system will consist of 3 modules: parameter recording, sampling, conformity assessment and also a management panel that will show the key process indicators and results. Parameter recording module was delivered in September 2023 and conformity assessment in February 2024. Sampling module and the management panel are under development with completion forecast in the end of 2025. [After the implementation of sampling module and the management panel, this review process will become part of routine.](#)

INPI/BR website is frequently updated to give information concerning notices, announcements, events, as well as courses and activities related to Intellectual Property. Also, all the important information related to the Institute is made available, including a session about most frequently asked questions (FAQ) related to different areas of INPI/BR, as well as all Brazilian laws and normative acts referred to Industrial Property.

Communication between WIPO and the designated and elected office at the INPI/BR is carried out by the PCT Division. It will forward all feedbacks from WIPO to the management and / or to the head of the involved technical department or to the patent examiners concerned.

This communication with WIPO and designated and elected offices are done mainly by e-mail. The feedback given by WIPO and the offices are evaluated and treated by the PCT General Coordinator and, if necessary, it is redirected to a specific technical division.

The documentation is available on different media such as INPI's BR portal <https://www.gov.br/inpi/en>, INPI/BR Intranet and INPI DRIVE (a web-based cloud storage), SISCAP system and provision of staff with a central source of information on how INPI/BR manage its processes in order to assure quality.

(v-vi) The Quality General Coordinator together with the PCT General Coordinator and Patent Quality Group organize all process implementation necessary to run QMS. INPI employs the process approach to develop, implement and improve efficiency of QMS. The responsibility for mapping the processes competes to PCT Unit which may request support from CQUAL which is INPI's Process Office. As long as changes are made in the processes, a critical review is made on the documentation in order to ensure that procedures in place are aligned with the process flows established.

The main decision and corrective actions decided by the Management are cascaded to the respective managers and processes may be reviewed. Every month is published on INPI/BR Intranet the main results and goals achieved on the previous month.

(iii) Training records, skills and experience, as well as the retraining of the staff involved in the ISA/IPEA process, are kept in the Human Resources General Coordination.

(iv-v) All evidences are stored on SISCAP system for quality analysis purpose and auditing. Reports are issued on quality activities.

(vi-vii) SISCAP system tracks and storages all work done on the search and examination process.

(viii) The results of QMS Audits are stored under the responsibility of Quality General Coordination.

(ix-xi) All action taken to correct and prevent nonconformity are stored in SISCAP and passed on internally to the head of divisions.

(xii) Guidelines for Search and Examination at the Patent Board are uploaded on SISCAP system and are also available on INPI/BR Intranet.
