

IPI Trademark API – Architecture & Features



- search for trademarks with a variety of filter options
- the scope of the delivered trademark data can be controlled to cover different use cases
- images can be obtained embedded as a Base64 string, as a URL or as an image file in a ZIP, together with the st.96 XML
- large result lists can be processed using paging
- the use of the service is free of charge, access is regulated by quotas to ensure fair use by all users
