### **PROPOSAL FOR REVISION OF WIPO STANDARDS ST.27, ST.61 AND ST.87**

*Document prepared by the International Bureau*

#### **SUMMARY**

1. The Legal Status Task Force (LSTF) proposes revisions to WIPO Standards ST.27, ST.61 and ST.87, which are related to legal status events. The revision to WIPO ST.87 was proposed by the Task Force to expand the supplementary data that is captured in Annex II to the Standard. The other proposed revisions are to ensure that the three Standards remain aligned.

#### **BACKGROUND**

2. The Legal Status Task Force has been working under the framework of Task No. 47 whose description reads:

*“Ensure the necessary revisions and updates of WIPO Standards ST.27, ST.87, and ST.61; prepare supporting materials to assist the use of those Standards in the IP community; and support the XML4IP Task Force to develop XML components for legal status event data.”*

3. In close collaboration with XML4IP Task Force, the LSTF has worked on updating WIPO Standard ST.87, Annex II (Supplementary Event Data), to support the development of XML schema for industrial design legal status events.

4. The LSTF Offices nominated industrial design experts to review Annex II of WIPO ST.87 to determine if there were any gaps in the supplementary data already captured by this Annex for each of the categories listed. The result of that review are the agreed revisions being proposed in the present document.

5. After the revision to WIPO ST.87 was agreed by the LSTF, the International Bureau, as the Task Force Leader, reviewed WIPO Standards ST.27 and ST.61, and proposed changes to the two Standards to ensure that they remain consistent with the revision to ST.87.

#### PROPOSED REVISION OF WIPO STANDARD ST.87

6. The LSTF has prepared a proposal for the revision of WIPO Standard ST.87 for consideration and where appropriate approval by the CWS, which is reproduced in Annex I to the present document using tracked changes. In Annex I, strike-through text indicates a deletion and underlined text indicates an addition.

7. The proposed changes to WIPO Standard ST.87 can be summarized as follows:

- (a) Update to list of references to add reference to WIPO Standard ST.96;
- (b) Clarification provided within paragraph 48 regarding the supplementary data provided in Annex II;
- (c) Update to Annex II to provide additional supplementary data for categories provided; and
- (d) Some editorial updates.

#### PROPOSED REVISION TO WIPO STANDARDS ST.27 AND ST.61

8. The International Bureau has prepared a proposal for revisions of WIPO Standards ST.27 and ST.61 resulting from the revision to WIPO Standard ST.87 and alignment among those legal status Standards. All changes are indicated in full in Annexes II and III respectively to the present document using tracked changes. In Annexes II and III, strike-through text indicates a deletion and underlined text indicates an addition.

9. The proposed changes to WIPO Standards ST.27 and ST.61 can be summarized as follows:

- (a) Update of list of references to add reference to WIPO Standard ST.87;
- (b) Clarification provided within paragraph 48 regarding the supplementary data provided in Annex II;
- (c) Update to Annex II to provide additional supplementary data for categories provided; and
- (d) Some editorial updates.

#### VERSIONING

10. As none of the legal status Standards have any versioning information, no new version number needs to be proposed for WIPO ST.27, ST.61 or ST.87. The date of publication of these Standards is considered sufficient.

(b) *consider and approve the proposed revisions to WIPO Standard ST.87 as referred to in paragraph 7 above, and detailed in Annex I to the present document;*

(c) *consider and approve the proposed revisions to WIPO Standard ST.27 as referred to in paragraph 9 above, and detailed in Annex II to the present document; and*

(d) *consider and approve the proposed revisions to WIPO Standard ST.61 as referred to in paragraph 9 above, and detailed in Annex III to the present document.*

48. The minimum supplementary event data related to a category is listed in Annex II. There are two groups of data: ~~data numbered (1) through (3) is a common supplementary event data set~~ which an IPO may provide for any national/regional/international event regardless of the category it maps to; and supplementary event data which numbered from (4) onwards is specific to that category. For further details refer to Annex II.

## IMPLEMENTATION

49. IPOs are encouraged to implement this Standard as soon as possible to facilitate the effective exchange of harmonized legal status data for applications and IP rights. Implementing this Standard will require that IPOs map national/regional/international events to the events defined in the Standard or at the very least a category.

50. It is recommended that when implementing this Standard, an announcement be made and the International Bureau of WIPO be informed by providing a mapping table of national/regional/international events to the events in this Standard on the basis of the model template available in Annex IV.

51. IPOs are requested to provide a title and description of their national/regional/international event codes in English such that users can obtain more information about the specific national/regional/international event. It is recommended that IPOs provide this information either along with the legal status data, or by providing the uniform resource identifier (URI) of their national/regional IP register or some other forum where this information is publicly available.

52. This Standard suggests that the frequency of exchange of legal status data should occur at one month intervals at a minimum, ideally at weekly intervals.

## ANNEX II

### SUPPLEMENTARY EVENT DATA

*Proposal for revision by the Committee on WIPO Standards (CWS)  
at its twelfth session on September 16, 2024*

1. Each status event code may be accompanied by supplementary event data. There is supplementary event data that is specific to events in a particular category and there is common supplementary event data which is common to all events. The common supplementary event data includes (1) the effective country or region, (2) the gazette issue number, (3) comment (i.e., free text), (4) a prior relevant event date, and (5) a relevant rule. The "effective country or region", is the country or region where the event has legal effect, which is particularly relevant for regional IPOs where the effect of an event, such as discontinuation due to non-payment of renewal fees, only has effect in some of the countries where the IP right is active. The "gazette issue number" is the issue of the national/regional gazette where the particulars of the national/regional/international event are made public. IPOs will be able to provide additional associated data which is not specified in the "comment" entry. The "prior relevant event date" is the date of a prior event which is relevant to the current event, such as the start of a fee payment time period which has expired. The "relevant rule" is an Office-specific rule, regulation, law, or other principle which was applied to reach the event outcome.

2. The Table below shows what supplementary data fields may be used for different categories. The first row shows common elements that may be used in any category, and subsequent rows show the data elements specific to each category. Note that the supplementary data elements indicated in this Standard are general descriptions of the types of data that may be provided. The particular formats and allowed values for supplementary data are defined in data representation standards, such as WIPO ST.96 for eXtensible Markup Language (XML).

## STANDARD ST.27

### RECOMMENDATION FOR THE EXCHANGE OF PATENT LEGAL STATUS DATA

*Revision presented for approval by the Committee on WIPO Standards (CWS)  
at its twelfth session*

*Editorial Note by the International Bureau*

*IPOs may begin implementing ST.27 to exchange legal status data. The Legal Status Task Force will continue revising titles and descriptions for categories and events as needed while IPOs continue to improve their mappings.*

*At its seventh session, the CWS has approved reserving three additional characters in the status event code for each event. These reserved characters are useful for future work on the standard, and are reserved now so that Offices can implement the existing standard with assurance. The Legal Status Task Force will explore proposals for using the reserved characters after the seventh session of the CWS and report any agreed proposals to the CWS. If no proposals are agreed by the Task Force, the reserved characters will remain unused but in place for possible future uses.*

#### Supplementary event data

50. This Standard recommends that IPOs provide additional information associated with events so that a user may understand the context in which the national/regional event occurred. This Standard provides the minimum supplementary event data that should be exchanged; IPOs can provide further information. Exchanging supplementary event data is optional.

51. The minimum supplementary event data related to a category is listed in Annex II. There are two groups of data: ~~data numbered (1) through (3) is common~~ supplementary event data which is common across all of the categories an IPO may provide for any national/regional event regardless of the category it maps to and supplementary event data which numbered from (4) onwards is specific to that category. For further details refer to Annex II.

#### IMPLEMENTATION

52. IPOs are encouraged to implement this Standard as soon as possible to facilitate the effective exchange of harmonized legal status data for applications and IP rights. Implementing this Standard will require that IPOs map their national/regional events to the events defined in the Standard or at the very least a category.

53. It is recommended that when implementing this Standard, an announcement be made and the International Bureau of WIPO be informed by providing a mapping table of national/regional events to the events in this Standard on the basis of the model template available in Annex IV.

#### Supplementary event data

48. This Standard recommends that IPOs provide additional information associated with events so that a user may understand the context in which the national/regional/international event occurred. This Standard provides the minimum supplementary event data that should be exchanged; IPOs can provide further information. Exchanging supplementary event data is optional.
49. The minimum supplementary event data related to a category is listed in Annex II. There are two groups of data: ~~data in the first row of the table is a common supplementary event data set~~ which an IPO may provide for any national/regional/international event regardless of the category it maps to; and a supplementary event data set in the row for a category which is specific to that category. For further details refer to Annex II.

#### IMPLEMENTATION

50. IPOs are encouraged to implement this Standard as soon as possible to facilitate the effective exchange of harmonized legal status data for applications and IP rights. 52. 53. This Standard suggests that the frequency of exchange of legal status data should occur at one month intervals at a minimum, ideally at weekly intervals.
