# Development and Implementation

- This project originated from our involvement in the Quality @Source 2021 initiative, under the EPO-IPOI cooperation agreement →
- Tasked with generating Authority File (AF) complying with data quality specifications
- System reconfigured by external developers for in-system AF generation
- XML output mandated to conform to ST.37 Version 2.2

- Customisable parameters: date of publication, kind codes, patent types, etc., enabling tailored statistical outputs →
- Initial output lacked kind code for priority documents – resolved with further development →
- System reconfigured to fully comply with ST.37 v2.2
- 2025 first publication on the WIPO portal

# Current State

- IE AF extraction covers utility models and full-term patents (1989–present)
- The data is in XML format and includes minimum data elements (paragraph 8) + priority application identification of the corresponding publication (paragraph 9(b)) as per ST.37 v.2.2
- Data split into separate files for accessibility
- Kind code changes post-2019 clearly explained in the Definition File

- Data retrieved directly from internal system Ptolemy, converted into XML format and spot-checked for consistency
- Published on IPOI website; linked via WIPO AF portal
- Updated and published twice yearly

# Challenges and further development

- If ST.37 v3 becomes mandatory, the IPOI will require recruitment of external resources and procedural changes
- Ongoing efforts to extend coverage to documents published between 1927–1989
- Goal: publish complete bibliographic data for all documents from 1927 onward
