

**Professor Marie-Elodie Ancel, Université Paris-Est Créteil, Val de Marne, Paris, France**

Marie-Elodie Ancel is Professor at the Law Faculty of the University Paris-Est Créteil Val-de-Marne (UPEC), where she teaches private international law and arbitration law. Ms. Ancel regularly publishes case notes and articles in private international law, especially in the field of contracts, intellectual property and e-commerce. Her first book was dedicated to “The Characteristic Performance of the Contract” and constituted in a research led in French contract law and European private international law. She is the co-author of a book on international contracts to be published in 2015, and she is also the co-founder and scientific director of Lynxlex, an online legal database (in progress) dedicated to the private international law instruments of the European Union.

**Professor Stefania Bariatti, University of Milan, School of Law, Milan, Italy**

Stefania Bariatti is Full Professor of International Law, Private International Law and International Insolvency Law at the University of Milan since 2002. Previously she was Full Professor of International Law and of European Union Law at the Universities of Sassari and Milano-Bicocca (1994-2002). Stefania is a member of the Governing Council of UNIDROIT and has been a member of the Italian Delegation to the Hague Conference of Private International Law for 14 years, where she has chaired the working groups and plenary session concerning the law applicable to securities held through an intermediary and has been a member of the drafting committee for the convention on maintenance obligations. She is of-counsel at Chiomenti Studio Legale and chairperson of the board of directors of a company listed at the Milan Stock Exchange. She has assisted the European Commission and the European Parliament in the drafting of several instruments in the field of judicial cooperation in civil matters. Stefania has published extensively on private international law, public international law and EU law in English, Italian and French and has presented reports at numerous conferences in Italy and abroad.

**Professor Joost Blom, University of British Columbia, Vancouver, Canada**

Joost Blom was educated at the University of British Columbia (B.A., LL.B.), Oxford (B.C.L.) and Harvard (LL.M.). He joined the Faculty of Law at the University of British Columbia in 1972 and has held the rank of Professor since 1981. He served as Associate Dean 1982-85 and as Dean 1997-2003. His areas of specialization are private international law, torts, intellectual property, and contracts. He has published extensively, mainly in private international law and torts. His book, written with P.T. Burns, *Economic Interests in Canadian Tort Law*, was published in 2009 (LexisNexis). He has held visiting appointments at Osgoode Hall Law School (York University, Toronto), the University of Trier (Germany), and Melbourne University. He is currently Treasurer of the International Academy of Comparative Law. He was an elected Bencher of the Law Society of British Columbia 2004-2011 and was designated Queen's Counsel (British Columbia) in 1985.

**Professor Andrew F. Christie**

Andrew Christie was appointed the foundation Chair of Intellectual Property at the Melbourne Law School in 2002. He has degrees in Science and in Law from the University of Melbourne, an LLM from the University of London, and a PhD from the University of Cambridge. Admitted to legal practice in Australia and the United Kingdom, he worked for many years in the IP departments of law firms in Melbourne and London. He is a former Fulbright Senior Scholar, and has held appointments at Duke University, the University of Toronto and the University of Cambridge.

**Professor Josef Drexl, Max-Planck Institute for Innovation and Competition, Munich, Germany**

Professor Dr. Josef Drexl LL.M. (UC Berkeley) is the Director of the Max Planck Institute for Intellectual Property and Competition Law in Munich (since 2002), an Honorary Professor at the University of Munich and a member of the Bavarian Academy of Science. As the Chair of the Board of Directors of the Munich Intellectual Property Law Center (MIPLC), Professor Drexl is responsible for an LL.M. program in IP with international outreach. He was the founding Chair of the Academic Society for Competition Law (ASCOLA) from 2003 to 2013, and he is a Vice-President of the Association Internationale de Droit Economique (AIDE). He acted as a visiting professor at Oxford University, the Libera Università Internazionale per gli Studi Sociali (LUISS) Guido Carli in Rome, the New York University and the Université de Paris 2 Panthéon-Assas. Professor Drexl is an expert in both competition law and intellectual property law. The competition law aspects of IP and international issues of both IP and competition law are among his major research interests.

**Professor Rochelle C. Dreyfuss, New York University, New York, United States of America**

Rochelle C. Dreyfuss is the Pauline Newman Professor of Law at New York University School of Law and Co-director of the Engelberg Center on Innovation Law and Policy at NYU. She holds B.A. and M.S. degrees in Chemistry, and a JD from Columbia University Law School, where she served as Articles & Book Review editor of the Law Review.

Dreyfuss clerked for Chief Judge Wilfred Feinberg of the U.S. Court of Appeals for the Second Circuit and Chief Justice Warren E. Burger of the U.S. Supreme Court. She was a co-Reporter for the ALI Project on Intellectual Property: Principles Governing Jurisdiction, Choice of Law, and Judgments in Transnational Disputes.

**Professor Mireille van Eechoud, University of Amsterdam, Amsterdam, Netherlands**

Mireille van Eechoud is professor of Information Law at the Institute for Information Law, University of Amsterdam, Netherlands. She directs the Law School's LLM program on Information Law. Her research and teaching span different areas of information law, including rights of access to public sector information and intellectual property rights. Professor Van Eechoud's work in private international law aspects of IP date back to her doctoral thesis *Choice of law in copyright and related rights, Alternatives to the lex protectionis* (Kluwer Law International 2003). She was a member of the European Max-Planck Group for Conflict of Laws in Intellectual Property (CLIP) and as member of the ILA committee on Intellectual Property and Private International Law she coordinates the work of the subgroup on initial ownership.

**Professor Jane C. Ginsburg, Columbia University, New York, United States of America**

Jane C. Ginsburg is the Morton L. Janklow Professor of Literary and Artistic Property Law at Columbia University School of Law, and Faculty Director of its Kernochan Center for Law, Media and the Arts. She teaches Legal Methods, Copyright Law, and Trademarks Law, and is the author or co-author of casebooks in all three subjects. With Professor Robert A. Gorman, she is the co-author of *COPYRIGHT: CONCEPTS AND INSIGHTS* (Foundation Press 2012), and with Professor Sam Ricketson, of *INTERNATIONAL COPYRIGHT AND NEIGHBOURING RIGHTS: THE BERNE CONVENTION AND BEYOND* (Oxford University Press 2006). Other books include several volumes on domestic or international copyright and trademark law. With Professor Dreyfuss and Professor François Dessemontet, she was a Co-Reporter for the American Law Institute project on *INTELLECTUAL PROPERTY: PRINCIPLES GOVERNING JURISDICTION, CHOICE OF LAW AND JUDGMENTS IN TRANSNATIONAL DISPUTES* (2008). A graduate of the University of Chicago (BA 1976, MA 1977), Professor Ginsburg received a JD in 1980 from Harvard, and a *Diplôme d'études approfondies* in 1985 and a Doctorate of Law in 1995 from the University of Paris II. She is a Corresponding Fellow of the British Academy, a Member of the American Philosophical Society, and an Honorary Fellow of Emmanuel College, University of Cambridge.



**Professor Toshiyuki Kono, Kyushu University, Fukuoka, Japan**

After he obtained his LL.B. and LL.M. at Kyoto University and passed the Japanese Bar Exam, he joined the faculty of law at Kyushu University. His main research field is private international law and international heritage law. His recent research interests are economic analysis of private international law. He gave special lectures on “Efficiency in Private International Law” at The Hague Academy of International Law in 2013, which will be published in its Pocket Book series.

He is currently, among others, Vice President and Titular Member of the International Academy of Comparative Law, Director of the International Academy of Commercial and Consumer Law, Chairman of the Committee for Intellectual Property and Private International Law of the International Law Association, Member of the Committee for Heritage Law of the International Law Association, Vice President of the Executive Committee of the International Council of Monuments and Sites (ICOMOS), Science Advisor of Ministry of Education, Cultures, Sport, Science and Technology of Japan as well as Chairman of the Committee for Cultural Affairs of UNESCO National Commission, Japan.

**Professor Gyoocho Lee, Chung Ang University, Seoul, Republic of Korea**

Gyoocho Lee is Professor of Law at Chung-Ang University School of Law in Seoul, Republic of Korea. He is author of scientific and teaching works in the field of intellectual property law, private international law, civil procedure, and arbitration. He has written several books including "Copyright Law-Cases And Explanations (2014)", "Patent Law-Cases And Explanations (2014)", "Teaching Intellectual Property Laws (2013)", "Failures of American Civil Justice in International Perspective (co-authored with James R. Maxeiner and Armin Weber and published by Cambridge University Press)(2011)", and "Recent Issues in Entertainment Law-Focused on Theories and Practices in Korea and Japan (co-authored with Kimihito Kato, esq., Tomoyuki Kataoka, esq., and Zung Hyuk Hur)(2011)."

He has also participated in drafting Japan-Korea proposals on private international law related to intellectual property. Currently, he serves as vice president of the Korea Infomedia Law Association, the Korea Computer Game Law Association, and the Association of Contents Property for Next Generation. Also, he is an arbitrator of KCAB (The Korean Commercial Arbitration Board), a director of KOSA (Korean Society of Authors) and ILA (International Law Association) Korean Branch, and a mediator at Seoul Central District Court.

**Dr. Rita Matulionyte, University of Newcastle, Callaghan, Australia**

Dr. Rita Matulionyte has been extensively researching and publishing in the areas of intellectual property, information technology and private international law for the last 8 years. She has written her PhD dissertation at the Max Planck Institute for Intellectual Property and Competition Law/Albert Ludwig University of Freiburg (Germany) and carried out her postdoctoral research at the Kyushu University (Japan) and in Iran, in cooperation with the Tehran University. Her research has resulted in over 20 publications in internationally recognized journals and presentations in a number of international conferences. She is currently a lecturer at the University of Newcastle, Australia and an associated research fellow at the Law Institute of Lithuania. Since 2010, she is an active member of the International Law Association where she coordinates a sub-committee on Applicable Law and IP.

**Professor Axel Metzger, Humboldt University, Berlin, Germany**

Axel Metzger (\*1971) is Professor of Civil Law and Intellectual Property at Humboldt-University in Berlin. First State Examination, Hamburg (1998); Dr. jur., Munich/Paris (2002); Second State Examination, Hamburg 2002; LL.M., Harvard (2006). Mr. Metzger is author and editor of numerous books and articles on intellectual property, information technology and European private law. Mr. Metzger was member of the European Max Planck Group on Conflict of Laws in Intellectual Property (CLIP). Before entering Humboldt University, he worked as Research Fellow at the Hamburg Max-Planck-Institute for Foreign and Private International Law (2002-2008) and as Professor at Leibniz University Hannover (2008-2014). He was visiting Professor in Basle (2011) and Bucerius Law School (2012).

**Professor Pedro De Miguel Asensio, Complutense University of Madrid, Madrid, Spain**

Pedro De Miguel Asensio is Chair Professor of Private International Law at the Complutense University of Madrid. He is the co-rapporteur of the Committee on Intellectual Property and Private International Law of the International Law Association. He was one of the drafters of the 2012 European Principles on Conflict of Laws in Intellectual Property as Member of the European Max-Planck Group on Conflict of Laws in Intellectual Property (CLIP). He is consultant at Allen & Overy.

**Professor Dário Manuel Lentz Moura Vicente, University of Lisbon, Lisbon, Portugal**

Full Professor (*Catedrático*) at the Faculty of Law of the University of Lisbon, where he obtained his PhD in Law and where he has taught for over 25 years, among other subjects, Civil Law, Comparative Law, Intellectual Property Law and Private International Law. He was a Visiting Professor at The Hague Academy of International Law, the Paris V University, the Complutense University in Madrid and the Urbino University. He has also taught extensively in other Portuguese-speaking countries, including Angola, Brazil, Cabo Verde, Timor-Leste, Guinea-Bissau, Goa (India), Macao (China) and Mozambique. He was Vice-Dean of the Faculty of Law of the University of Lisbon and is currently Chairman of the Institute for Juridical Cooperation of the same Faculty. He is the Editor of the *Revista Internacional de Arbitragem e Conciliação* and the *Revista de Direito Intelectual*. He is an Associate Member of the Académie Internationale de Droit Comparé, Chairman of the Portuguese Society for Intellectual Property Law and a member of the Board of Directors of the Portuguese Society for Arbitration. He was a member of the drafting committee of the Portuguese Law on Voluntary Arbitration of 2011.

## **Marta Pertegás, First Secretary, Hague Conference on Private International Law**

Ms. Pertegás joined the Hague Conference on Private International Law in February 2008 and is currently First Secretary. Ms. Pertegás focuses on the Hague International Litigation Conventions and other projects related to commercial international law. She has primary responsibility for the Hague Conference project on the development of an international instrument to reinforce choice of law agreements globally, *i.e.*, the future Hague Principles on Choice of Law in International Commercial Contracts; for the Judgments Project on the development of an international Convention on recognition and enforcement of judgments, and for the 2005 Choice of Court Convention.

Ms. Pertegás studied law at Barcelona University, Spain; she completed a Master of Laws and a PhD thesis on “Cross-border enforcement of patent rights” at Leuven University, Belgium. From 2002 to 2008, Ms. Pertegás held a tenured full-time position at Antwerp University, Belgium. She still lectures on the “Law of Global Transactions and Litigation” in Antwerp on a part-time basis.

**Professor Marketa Trimble, University of Nevada, Las Vegas, United States of America**

Marketa Trimble is an Associate Professor at the William S. Boyd School of Law, University of Nevada, Las Vegas. In her doctrinal, comparative, and empirical research she focuses on intellectual property and issues at the intersection of intellectual property and private international law/conflict of laws, with a particular emphasis on problems arising on the Internet. Oxford University Press published Professor Trimble's 2012 book entitled *Global Patents: Limits of Transnational Enforcement*, which examines cross-border enforcement issues arising in patents. She co-authors, with Professor Paul Goldstein of Stanford Law School, the third edition of the casebook *International Intellectual Property Law*, and has authored numerous articles on intellectual property law and conflict of laws issues in intellectual property law.



**Professor Benedetta Ubertazzi, Macerata University, Macerata, Italy**

Benedetta Ubertazzi was born in Milan on September 9, 1975. She is currently tenured as an Aggregate Professor of international law at the School of Law, University of Macerata. Fellow of the Alexander Von Humboldt Foundation, under the program of Fellowship for experienced researchers hosted by the Max Planck Institute for Competition and Innovation, Munich, Germany. She acts as a legal expert representing the Italian Ministry of Foreign Affairs in multinational negotiations occurring at the UNESCO's Intergovernmental Committee for the Safeguarding of the Intangible Cultural Heritage, and her most recent publication is: Exclusive Jurisdiction in Intellectual Property, Mohr Siebeck, Tübingen, 2012, pp. 341, published in "Studien zum ausländischen und internationalen Privatrecht", Series of Books of the Max Planck Institut for Comparative and International Private Law.
