 WIPO is also supporting us with the project on IP Model Office and this project will enable us to leverage ICT for increased efficiency and effectiveness in offering IP services online.

My delegation is hopeful that, with the pandemic ceasing to prohibit movement and effective engagements, the various committees of the Organisation will now commence their norm-setting work in earnest. We wish to make specific mention of our hope in progressing the DLT and finalisation of the work of the IGC.

9. My delegation commits itself to working with other Member States to ensure that these Assemblies make decisions that will continue to grow the organisation and its impact in advancing IP for development amidst socio-economic aftermath of Covid 19 in the member states and the world over.
