- The year 2023 brought with it a significant increase in applications for registration of intellectual property rights in Israel in all sectors. Within the patents' field, 1636 applications for registration of a patent in Israel were filed, 32,111 applications for registration of trademarks, and 3110 applications for registration of designs ( if time allows: an increase of 31.1%, 30% and 21%, respectively, compared to the previous year).
- The considerable increase in applications for patents registration testifies to the centrality of intellectual property rights and its importance in promoting the business layout in Israel.
   Furthermore, the Israel Patent Office is operating in a great degree in the international arena, for promoting collaborations and positioning the State of Israel as an influential factor in the field.
- In 2023, Israel made the artificial intelligencebased search software a priority, which it uses for search of prior art, available for public use as well.
- Therefore, Israel welcomes WIPO's efforts to support a balanced and well-functioning global IP ecosystem for the benefit of all.
