INTRODUCTION

1. This Summary Report records the decisions of the following three Assemblies of the Member States of WIPO (the “Assemblies”):

- (1) WIPO General Assembly, fifty-ninth (32nd extraordinary) session
- (2) Paris Union Assembly, sixty-second (35th extraordinary) session
- (3) Berne Union Assembly, fifty-sixth (29th extraordinary) session

ITEM 1 OF THE CONSOLIDATED AGENDA

OPENING OF THE SESSIONS

3. The Sixty-Seventh Series of Meetings of the Assemblies of WIPO was convened by the Director General of WIPO, Mr. Daren Tang.

4. The sessions were opened in a joint meeting of the three Assemblies by the Chair of the WIPO General Assembly, Ambassador Mr. Carlos D. Sorreta (Philippines).

"The WIPO General Assembly and the Assemblies of the Paris and Berne Unions, each as far as it is concerned,

(i) considered the nomination of the WIPO Coordination Committee referred to in paragraph 3 of document A/67/2; and

(ii) appointed Mr. Daren Tang as Director General of WIPO for a term from October 1, 2026 to September 30, 2032."

"The WIPO General Assembly fixed the conditions of the appointment of the Director General as reflected in the draft contract set out in Annex II to document WO/GA/59/1.
