ELECTION OF THE MEMBERS OF THE WIPO BUDGET COMMITTEE

Memorandum of the Director General

1. The WIPO Budget Committee was established in 1976 with ten elected countries as members and Switzerland as a ($\underline{de \ facto}$) <u>ex officio</u> member. As from 1978, the number of elected countries was raised to 13. Although there were six elections during the 12 years following the first election (in 1976), membership changed only very little. The results of each election and the situation up to September 1993 (when new elections will take place) are reflected in the following table:

2. The mandate of the countries elected in the September 1993 sessions of the Governing Bodies will last for the next two bienniums (or four years), namely, the years 1994, 1995, 1996 and 1997. Switzerland's (<u>ex officio</u>) membership will continue.

3. The WIPO General Assembly and the Assemblies of the Paris and Berne Unions are invited to elect 13 countries as members of the WIPO Budget Committee for the period from January 1, 1994, to December 31, 1997, and to note the continued <u>ex</u> officio membership of Switzerland.
