Introduction

- (iii) the authority (in most cases, a treaty provision) which makes it mandatory or possible for the Governing Body or Governing Bodies concerned to deal with the matter,
 - (iv) the preparatory documents, if any,
- (v) the action which the item calls for (in most cases, a reference to the applicable paragraph or paragraphs of the preparatory document or documents).

Berne Union Executive Committee: Mr. Mart Leesti (Canada),

provided that the officers of the Paris Union Executive Committee
must be elected from among the delegates of the ordinary members (those
members are listed in document AB/XXV/INF/1 Rev.) of that Executive
Committee (see Rules of Procedure of the said Executive Committee,
Rule 3),

provided that the officers of the Berne Union Executive Committee must be elected from among the delegates of the ordinary members (those members are listed in document AB/XXV/INF/1 Rev.) of that Executive Committee (see Rules of Procedure of the said Executive Committee, Rule 3(4)),

and provided that the Chairman and the second Vice-Chairman of the WIPO Coordination Committee must be elected from among the delegates of the ordinary members of the Executive Committee of the Paris Union, whereas the first Vice-Chairman of the WIPO Coordination Committee must be elected from among the delegates of the ordinary members of the Executive Committee of the Berne Union (the members of the two Executive Committees are listed in document AB/XXV/INF/1 Rev.; see Rules of Procedure of the WIPO Coordination Committee, Rule 3).

<u>Decisions invited</u>: Each of the three Committees is invited to elect one Chairman and two Vice-Chairmen.
