INFORMATION ON THE STATES NOT PARTY TO THE ROME CONVENTION BUT  
PARTY TO THE INTERNATIONAL COPYRIGHT CONVENTIONS REFERRED TO IN  
ARTICLE 24 OF THE ROME CONVENTION

*Memorandum prepared by the Secretariat*

*Item 5 of the Provisional Agenda*

1. Article 24, paragraph 2, of the Rome Convention provides as follows: “This Convention shall be open for accession by any State invited to the Conference referred to in Article 23, and by any State Member of the United Nations, provided that in either case such State is a party to the Universal Copyright Convention or a member of the International Union for the Protection of Literary and Artistic Works.”

2. To indicate for which States accession to the Rome Convention is open and which of them actually have acceded to it, a comparative table is presented herewith reflecting the status of adherence to the three Conventions concerned on October 15, 2008 (in the table, BC means that the State concerned is party to the Berne Convention for the Protection of Literary and Artistic Works (Berne Convention) and thus is a member of the International Union for the Protection of Literary and Artistic Works (Berne Union) referred to in the above-quoted provision; UCC means that the State concerned is party to the Universal Copyright Convention; RC means that the State concerned is party to the Rome Convention).
