Memorandum of the Director General

APPOINTMENT OF A DEPUTY DIRECTOR GENERAL (CONTINUATION)

- 1. Enclosed to this memorandum are translations of a letter of September 8, 1993, of the Permanent Representative of Cameroon in Geneva to the Director General of WIPO and its annex, the latter being a copy dated November 20, 1992, of a note verbale of the Permanent Mission of the said country to WIPO (Annex I). Also enclosed are translations of a note verbale of the International Bureau of WIPO to the said Permanent Mission of December 7, 1992 (Annex II), of a note verbale of the said Permanent Mission to WIPO of May 24, 1993 (Annex III) and of a note verbale of the International Bureau of WIPO to the said Permanent Mission of June 1, 1993 (Annex IV).
- 2. This correspondence is published pursuant to the request of the Permanent Representative of Cameroon.
- 3. It is to be noted that the Permanent Mission's note verbale of November 20, 1992, was sent more than three months earlier than the date on which consultations concerning the post of Deputy Director General have started and more than five months before the circular note verbale dated April 30, 1993, inviting the presentation of candidatures.

- 4. In any case, the date of receipt of the applications has no relevance. All applications have the same validity.
- 5. With regard to paragraphs 7 and 8 of the letter of September 8, 1993, it is to be recalled that in the Director General's circular note verbale of April 30, 1993, the following is stated: "In the November 1991 session of the WIPO Coordination Committee, the Director General said that in '1993, he would propose to the Coordination Committee, if he finds a suitable candidate—and he had no doubt that it will be possible to find such a candidate—to approve the appointment, for two years of a national of an African developing country to succeed Mr. Alikhan' (WIPO document WO/CC/XXIX/4, paragraph 45)."
- 6. The curriculum vitae of each applicant has been presented in a summarized form in documents WO/CC/XXXI/2 and WO/CC/XXXI/4, containing all the relevant information. But in view of paragraph 9 of the letter of September 8, 1993, a copy (translation) of the curriculum vitae of each of the candidates, as received by the International Bureau of WIPO, is attached to this document (Annex V).
- As to the proposed duration -- two years -- of the proposed appointment, the 7. circular note verbale of WIPO of April 30, 1993, and document WO/CC/XXXI/2, state that that period was mentioned in the November 1991 session of the WIPO Coordination Committee and that those two years would expire, as is customary, at the same time as the appointment of the Director General. The reason of this custom is that any newly elected Director General should be free--subject to the WIPO Coordination Committee's approval -- to appoint Deputy Directors General of his own choice. However, there is no rule which would prevent the appointment of any Deputy Director General for a term that continues after the change of the person of the Director General. If the WIPO Coordination Committee considers that any newly elected Director General does not need the freedom to appoint -- subject to the WIPO Coordination Committee's approval -- Deputy Directors General of his own choice, the term of appointment of Deputy Directors General could be longer than the two years proposed in this case, proposed--it is recalled--because the present Director General's term expires in two years' time.
- 8. The fact that this memorandum does not deal with all the other elements of the letter of September 8, 1993, does not mean that the Director General agrees with them and he will deal with them, if still necessary, in the discussions in the meetings of the WIPO Coordination Committee.

#### ANNEX I

LETTER FROM THE PERMANENT REPRESENTATIVE OF CAMEROON TO THE DIRECTOR GENERAL OF WIPO (Translation by the International Bureau of WIPO)

Geneva, September 8, 1993

Subject: Appointment of a Deputy Director General of WIPO

Dear Mr. Director General,

- 1. After having read your memorandum published under document No. WO/CC/XXXI/2, dated August 16, 1993, I have the honor to point out to you, with a view to restoring the truth, that it contains some errors which I should like to think are involuntary.
- 2. Your skill in keeping this affair vague, both in your private conversations and in the course of group consultations, is causing your opposite numbers to wonder just what kind of heir you intend to leave at the head of WIPO when your present term of office comes to an end.
- 3. As for the errors, we would point out first that the order in which the candidatures were received, as given in paragraph 10 of the document in question, is not accurate.
- 4. You will indeed remember that, contrary to your statement, the candidature of Mr. Jean FOUMANE AKAME was submitted to you not on May 24, 1993, but by note verbale No. 190/NV/MPCG of November 20, 1992, a photocopy of which is enclosed.
- 5. Out of courtesy, I shall leave you to take care of publishing the tactical reply which was sent to me at the time in order to preserve the chances of your own candidate, whom you thought you would be able to impose on the consensus of the African Group at your working luncheon on February 25, 1993.

- 6. Indeed it was the failure of that tactical move that explained your anger on receiving the letter from the Chairman of the African Group in which you were requested first to publish the vacancy announcement and only then to announce the choice of your preferred candidate.
- 7. The second error lies in your threat, by rejecting the principle of rotation, to prompt candidatures from the other regional groups if the Africans did not rapidly give in to your notoriously precipited choice.
- 8. Today one is bound to observe that, apart from Africa, you have not recorded any candidature from the Third World. That certainly strengthens our arguments according to which there is a consensus within the Group of 77 on the principle of rotating the post in question, and confirms that there is solidarity among the developing countries in the search for a candidate who of course should be competent, but above all capable of defending their interests and working together with the Director General, with due respect for the hierarchy, but without subservience or complicity.
- 9. Clearly, this does not seem to be your way of looking at things. In order to favor your <u>protégé</u>, you considered it quite normal to cut down his competitor's curriculum vitae, to present it in an unbalanced fashion, to make value judgements on the connections and international relations of each candidate, as if the members of the Coordination Committee were incapable of making any personal assessments.

Who said that the age of the diktat was past?

- 10. What use is there in consulting the Coordination Committee if the arbitrary choice made by the Director General is to be endorsed without a shot being fired? Does the Director General of a specialized agency henceforth have to be personally acquainted with his deputy or any other collaborator before he agrees to work with him? When this is done by an international official, what then becomes of the requirement of a spirit of non-discrimination? These are the simple questions to which, in due conscience, you have now to reply.
- 11. There is no doubt that the members of the Coordination Committee will spot the hidden trap in paragraphs 5 and 14 of your memorandum and will demand guarantees to ensure that the African mandate is neither curtailed nor tied up with conditions. Above all do not forget that the Coordination Committee is entitled to refuse your choice, as indeed it already has in the past.

- 12. Having said that, I wish to make it clear that Cameroon has absolutely nothing against your preferred candidate as a person. Our only concern is that there should be respect for principles and elementary rules of procedure.
- 13. I ask to have this letter distributed as an official document of the 24th ordinary session of the Coordination Committee.

I had the privilege of prosecuting before the various Judges of the Assizes, the longest period of prosecution at that time was spent before konourable Justice Bakare now (retired). My star case in the field of prosecution, the State Vs. Olufunmilayo Bankole, was a celebrated murder case in which a renowned Professor Bankole and his wife were murdered in their sleep, by his own brother Olufunmilayo Bankole, who then proceeded to set fire to the house of the deceased. This case was particularly of interest as all witnesses were member of the same family, who tended to turn hostile. The case was successfully prosecuted by me to conviction at the Assizes. I also wrote the brief thereafter, for the D.P.P. for the appeal at the Supreme Court.

#### LEGAL DRAFTING DIVISION:

I spent a short period of six months in the section dealing with legislative drafting - the zoning of Victoria Island Edict of the period was drafted by me. After the six months, I was recalled to the Director of Public Prosecutions Department to continue in that Section as the prosecuting Counsel to handle appeal cases at the Federal Court of Appeal.

Varied cases within the purview of the criminal code were assigned to me, these include cases of Rape, Arson, Assaults etc.

In the area of Prosecution, I was initially assigned to Court No. 4, Yaba, as the Prosecuting Officeron Priliminary Investigations, thereafter, cases handled by me at the level were prosecuted by me at the High Court of the State. I was later assigned as the prosecuting Officer at the Quarterly Criminal assizes in the High Court at Lagos, due to shortage of staff (as one or two) of our Seniors were elevated to the Bench. I remained in that section till 1980 when I transferred my services to the Federal Government of Nigeria.

I transferred my services from Lagos State Government to the Federal Government.

I was first posted to the Department of Civil Litigation and Public Laws, where I worked as the second in command and under the supervision of Mr. Fidelis Nwadialo, now a Senior Advocate of Nigeria.

I prosecuted civil cases at the High Courts of Lagos State, Federal High Courts and other High Courts and other States in the Federation, i.e. Oyo, Plateau, Ogun, Rivers, Kano States etc.

I was posted as the Legal Adviser to the Federal Ministry of Health.
