NOMINATION TO THE POST OF DIRECTOR GENERAL (Addendum)

Memorandum by the International Bureau

1. This document is an addendum to document WO/CC/XXXIII/1 of July 18, 1994.

2. That document describes the procedure of nomination (by the WIPO Coordination Committee in September 1994) and appointment (by the WIPO General Assembly in September 1995) to the post of Director General (paragraph 1). It indicates that the Chairman of the WIPO General Assembly notified the Member States of WIPO of the possibility for any Member State of WIPO to propose a candidate for the said post (paragraph 2).

3. The said document also indicates that, in response to that invitation of the Chairman, the Government of the United States of America proposed, in a note dated May 19, 1994, the candidacy, for an additional two-year term (expiring on November 30, 1997), of Dr. Arpad Bogsch, the current Director General (paragraph 4).

4. Finally, the above-mentioned document states that any further candidacies would be notified to the Member States of WIPO and would be the subject of addendums to that document (paragraph 5).

5. A further candidacy has been received in the meantime. It concerns Mr. Jean-Loup Tournier, a French citizen. The note of the Permanent Mission of France in Geneva and the curriculum vitae accompanying that note (received on July 19, 1994) are annexed to the present document.
