


## Current process

- MOP office user uploads a document with a list of IRN-s and submits it to WIPO as "Other mail".
- In Madrid chancellery the request has to be inserted to Madrid Registry via the back-office application.
  - IRN-s need to be manually extracted from the document.
  - The document needs to be printed out and scanned back in together with a generated bar-code.

## New MOP GP list process

- There is a new tab specifically for sending GP lists.
- The list of IRN-s is validated before submission to WIPO
   there can be no duplicates or IRNs in wrong format.
- User can submit maximum of 100 IRNs at once. If there is more than 100 IRN-s to be submitted, then multiple lists need to be submitted.
- Grant of protection decisions can be tracked on MOP Documents tab.


