CITA CITRAWINDA

Ms. Citrawinda is an IP Consultant for Law Office Cita Citrawinda Noerhadi & Associates in Indonesia. She earned a Bachelor degree in Law from the University of Indonesia, Jakarta (1985); Master degree in Intellectual Property from Franklin Pierce Law Center, Concord, New Hampshire, USA (1993); and a Doctorate with honors in Law from the University of Indonesia, Jakarta (1999) on Trade Secret. Her dissertation entitled Indonesian Legal Culture Facing Globalization: Trade Secrets Protection in the Field of Pharmaceutical. Cita is Secretary and one of Founders of IP Arbitration and Mediation Body (BAM HKI); one of Advisory Members of Indonesian Association of Intellectual Property Consultant (Asosiasi Konsultan HKI Indonesia/AKHKI); Deputy II of Indonesian IP Academy (IIPA); the President of Association Internationale pour la Protection de la Propriete Intellectuelle (AIPPI) (period of 2009 – 2014) and Trade Secret Committee for Indonesian Group; Patent Committee for Indonesian Group of Asian Patent Attorneys Association (APAA); Member of International Trademark Association (INTA); Member of INTA International Amicus Committee – Asia Pacific/Canada Subcommittee; and Member of American Intellectual Property Law Association (AIPLA). She chaired the Indonesian Intellectual Property Society (IIPS) in 1996 – 2000 and 2000 – June 2001 and was one of Advisory Members of the Indonesian Group Country Head of ASEAN Intellectual Property Association (AIPA) period of 2003 – 2009.

She is a member of the Preparation Team of the Draft of Law Concerning the Amendment of Law No. 14 of 2001 concerning Patent, Amendment of Law No. 15 of 2001 concerning Mark; member of national team for the Negotiation on International Trade (Tim Nasional untuk Perundingan Perdagangan Internasional/PPI), a member of a special team on the preparation of Intellectual Property regulations and the implementation of laws and regulations, particularly in relation to State aid where issues of Intellectual Property law must be in compliance with the provisions under *the Trade Related Aspects of Intellectual Property Rights – World Trade Organization* (TRIPS-WTO). Cita acted as a national consultant for the Drugs and Food Control Body in the preparation of the prevailing Indonesia Patent Law of 2001 on public health aspects. She is also a local expert at National Project Coordination Committee for ASEAN-Rockefeller Project in Intellectual Property Review and Capacity Building on Intellectual Property Rights Related to Public Health in the ASEAN region (2004). In addition, she often acts as an expert witness in various IP cases.

CANDRA N. DARUSMAN

Mr. Darusman, a national of Indonesia, had previously lived in Yugoslavia, Mexico, the former Soviet Union and occasionally in Switzerland. Joined WIPO Geneva, in April 2001, as Consultant, he currently holds the position as the Deputy Director/Officer-in-Charge of the WIPO Office in Singapore. Until 2001, he was the General Manager of the Indonesian Collective Management Organization (KCI), a position which he held since the establishment of the organization in 1990. He was also the Secretary General of The Indonesian Musicians Foundation (YAMI).

He is an economist graduate (Doctorandus – PhD. candidate) from the Faculty of Economics, University of Indonesia, and from 1982 to 1985 was a researcher, lecturer and served as assistant Professor at the Faculty, specializing on Macroeconomics and Micro economics. From 1985 to1986 he worked as a banker at Citibank and in 1987 he entered into the music production and recording business. From 1986 to 1991 he served as Director to the Indonesian Guild of Composers. From 1994 to 1996 he was appointed a member of the Indonesian National Copyright Council by presidential decree. He served as Director of the Indonesian Musicians Cooperative (KOSMINDO), a small and medium enterprise cooperative with the task of seeking venture capital for artist-entrepreneurs. At the same period Mr. Darusman was also an active member of the Anti-Piracy Coalition of the Indonesian copyright industries.
