

# Recording of a License - Rule 20bis

- License: an IP agreement between an IP rights owner and someone who is authorised to use the rights in exchange of a fee or a royalty.
- A number of CPs are not covered, either where recording of Licenses are not accepted or where recording has to be made directly before that Office (note (a) in Item 5).
- Do not send supporting documents to WIPO.

# Rule 20 Rule 20

- The holder of an international registration or the Office of the Contracting Party of the holder, or the Office of any designated Contracting Party, may inform the International Bureau that the holder's right to dispose of the International Registration has been restricted.



# Partial or total Removal of the Restriction Rule 20(2)




