

  - 产权组织所致的错误: 没有时间限制

- ■被指定缔约方的主管局
- ■请求更正的主管局



# 第28条第(3)款

■ 当国际注册作出更正: 自通知更正之日起,被指定的缔约方主管局可以发出临时驳回通知。



# 第28条第(4)款

■错误由主管局所致,并且更正会影响由国际注册所产生的权利时,请求更正的时限为:公布之日起九个月内。

# 受让人的资格

- ■中国大陆对议定书的加入不适用于中国香港和中国澳门
- 在中国香港成立或以中国香港为居所的<u>实体</u>,不具备成为 国际注册持有人的有效资格
- 必须有在中国大陆(或某其他马德里体系缔约方)的地址



# 国际注册的续展

- ■国际注册的有效期以十年为期
- ■以十年为一期续展



# 国际注册的续展

- ■可仅对部分被指定缔约方续展
- 如果国际注册簿上已登记对有单独规费要求的被指定缔约方的<u>部分保护</u>(细则第18条之三第(2)款)(ii) 项或第(4)款),则应缴纳的规费数额应仅根据给予保护的商品和服务计算。
- 如果国际注册簿上已登记<u>全部驳回</u>(细则第18条之三),则续展应针对所有商品和服务。



- 国际注册已经续展的,产权组织将续展通知有关被指定缔约方的主管局,并将续展注册证寄给注册人
- 如果国际注册未予续展,或对某被指定缔约方未予续展, 产权组织应通知被指定缔约方、注册人和代理人
