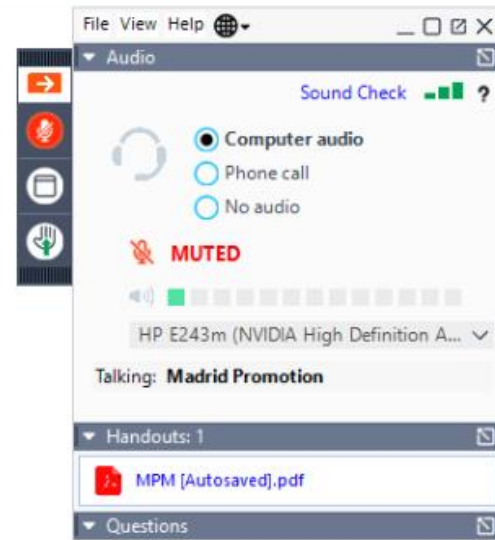

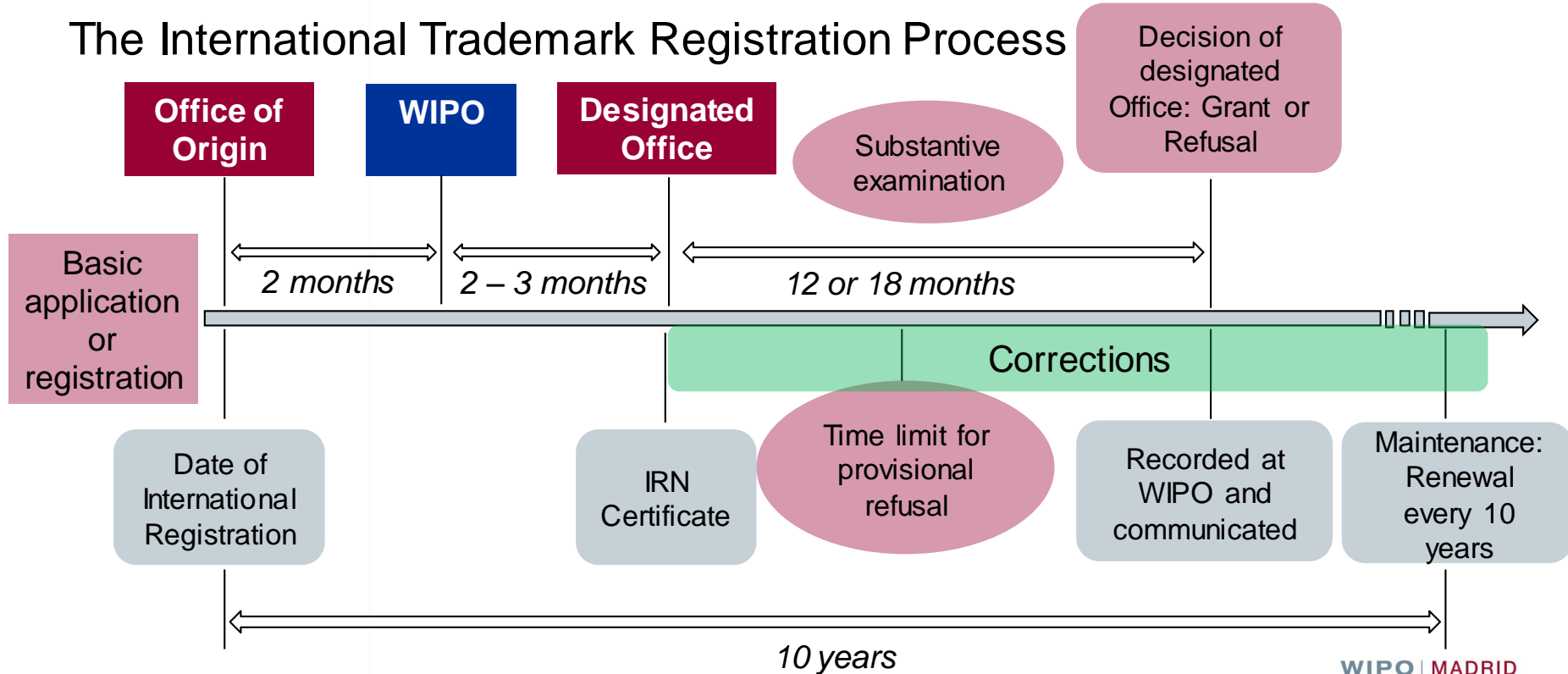

What are corrections?

Rule 28

- (1) *Corrections*
- (2) *Notification of correction*
- (3) *Refusal following a correction*
- (4) *Time limit for Offices to request a correction: 9 months*

Rule 28 (1)

- The WIPO carries out corrections of **International Registrations** in the following cases:
 - **Errors by an Office:** requested by the Office within 9 months from the date of publication
 - **Errors by the International Bureau:** no time limit
 - **Errors by an Office the correction of which would not affect the rights deriving from the international registration:** any time and presented by the Office

Admissible or not?

- A holder sends a correction request directly to WIPO. The error was made by the holder as they made a mistake in the name of applicant provided in the international application.

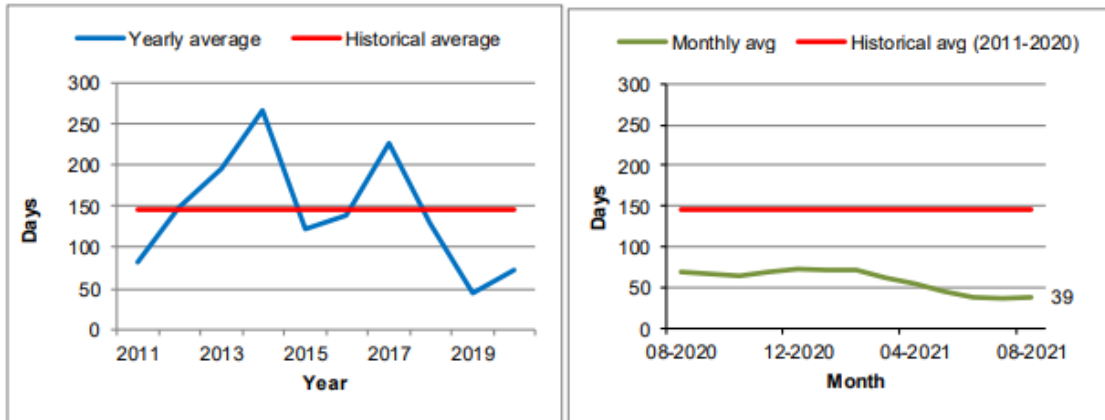

Question 1: Correction on NICE

Int'l Reg. No.: 1611985 WIPO ref.: 806/1446209601 Our ref.: F12508

Concerning the list of goods in the Certificate of Registration for IR 1611985, we found that several indications of the word “dewaters” have been changed to “dewater” (i.e., the “s” has been removed) in 5 places, while 1 “dewaters” remain unchanged.

Please find attached a copy of the Certificate of Registration (IR1611985) indicating where the errors occur. (highlighted in yellow). In total, there are 5 indications that require amendment (4 in class 7 and 1 in class 11). For reference, we have underlined (green) the correct indication of “dewaters”.

As we believe this is a typographical error made by WIPO and “dewaters” is linguistically correct, we ask you to kindly make the necessary corrections to change the 5 highlighted indications of “dewater” to “dewaters”.

Question 8: Duplication of Subsequent Designation

For reasons unknown to us, the requested subsequent designation **has been published a second time** by WIPO. According to the Madrid Monitor, the first publication is dated "2021/15 Gaz, 29.04.2021, IN, RU", and the second publication is dated "2021/16 Gaz, 06.05.2021, IN, RU".

In Russia, this has led to the situation that one designation is cited against the other. We have received an official letter from the Russian Office requesting that the second subsequent designation / publication is formally withdrawn, and that the withdrawal shall be published in the Madrid Monitor.

We are not aware of any second subsequent designation; to our knowledge, the subsequent designation was requested only once by us, namely on 08/04/2021.

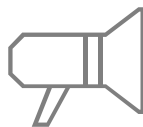
