
## Ms. Melissa Morgia

The department also monitors and landscapes emerging technologies that pose threats and opportunities for the music industry.

Prior to her current role, Melissa was the Acting Director of Global

Litigation at IFPI. She also previously held legal positions in the Intellectual Property departments at the BBC and in private practice.

In addition to degrees in Law and Communications, Melissa holds a Post-Graduate Diploma in Intellectual Law and Practice from the University of Oxford and also recently completed the Oxford Artificial Intelligence Programme.
