Introducing Standard Essentiality Verification Information Provided by Patent Pools

WIPO Headquarters (Room A), Geneva, Switzerland (Hybrid format)

Building on the “Declared SEPs” feature introduced in 2025 – which made those patents searchable in PATENTSCOPE that have been declared as essential to standards adopted by three Standard Developing Organizations (SDOs) – WIPO now integrates standard essentiality verification information provided by patent pool administrator Sisvel.

Sisvel is the first to join WIPO's initiative. Founded in 1982 in Italy, Sisvel is now a global company and the only European patent pool administrator. Sisvel routinely publishes and updates lists of patents in their licensing programs evaluated by independent third-party evaluators. Through the integration of data on these lists into PATENTSCOPE, information on verified essentiality will now be readily accessible to users worldwide attached to the patent records in the database. WIPO is working towards inclusion of information from further patent pool administrators as well.

SEPs are patents that protect inventions which are essential to the implementation of a particular technology standard. Standards – such as mobile communication standards (4G, 5G), Wi-Fi, and video compression standards like H.264 – ensure interoperability among devices and across borders. With the rapid expansion of the Internet of Things (IoT) and the increasing use of smart devices, standardization and broad access to reliable data are becoming even more important.

In line with [WIPO's SEP Strategy](#), the new feature in PATENTSCOPE enhances transparency through voluntary industry collaboration.
