## KENYA'S JOURNEY



- A National Development Agenda
- TK,TCE's and GR Policy
- The Constitution 2010 –devolved system of Government, National and County Government
- Relevant Policy Documents-Cultural Policy ,Vision,Mission,Mandates
- IPLCs-42 tribes in Kenya with different languages and cultures that all merge to become the unique mix of Kenyan culture
- State's recognition of support, promotion and protection of intellectual property- Parent Ministry- Ministry of Culture and Heritage, State Department of Culture
- Regional and International instruments

"cultural expressions" means any forms, whether tangible or intangible, in which traditional culture and knowledge are expressed, appear or are manifested, and comprise of the following forms of expressions or combinations thereof—

- verbal expressions including stories, epics, legends, poetry, riddles; other narratives; words, signs, names, and symbols; (Communities in Kenya)
- musical expressions including songs and instrumental music;

### CONT'D



- expressions by movement, including dances, plays, rituals or other performances, whether or not reduced to a material form;
- tangible expressions, including productions of art, drawings, etchings, lithographs, engravings, prints, photographs, designs, paintings, including body-painting, carvings, sculptures, pottery, terracotta, mosaic, woodwork, metal ware, jewelry, basketry, pictorial woven tissues, needlework, textiles, glassware, carpets, costumes; handicrafts; musical instruments, maps, plans, diagrams architectural buildings, architectural models; and architectural forms;



### TCES MODE OR FORM

- the products of creative and cumulative intellectual activity, including collective creativity or individual creativity where the identity of the individual is unknown;
- characteristic of a community's cultural identity and cultural heritage and have been maintained, used or developed by such community in accordance with the customary laws and practices of that community;
- generated, preserved and transmitted from one generation to another, within a community, for economic, ritual, narrative, decorative or recreational purposes;
- individually or collectively generated; belongs to a community; and
- integral to the cultural identity of community that is recognized as holding the knowledge through a form of custodianship or guardianship



### ROLE OF CUSTOMARY LAW

- Determining the **equitable sharing of benefits** from the commercial exploitation of TK
- Determining the **distribution of damages/compensation** in the infringement of IPRs
- Importance of recognizing the international **instrument>national treatment, reciprocity, mutual recognition**

## PROTECTION OF TK AND TCE'S ACT 2016

- Sui generis : used to describe a form of legal protection that exists outside typical legal protections that is, something that is unique or different.
- Swakopmund Protocol for TK and TCEs



## BENEFICIARIES OF **PROTECTION**




- The local and traditional communities, and recognized individuals within such communities, who create, preserve and transmit knowledge in a traditional and intergenerational context
- The owners of the rights in expressions of folklore shall be the local and traditional communities: to whom the custody and protection of the expressions of folklore are entrusted in accordance with the customary laws and practices of those communities; and who maintain and use the expressions of folklore as a characteristic of their traditional cultural heritage.

## HOLDER OF TK/TCE'S OWNER OF TK/TCE'S



- holder means recognized individuals or organizations within communities in whom the custody or protection of traditional knowledge and cultural expressions are entrusted in accordance with the customary law and practices of that community;
- owner means local and traditional communities, and recognized individuals or organizations within such communities in whom the custody or protection of traditional knowledge and cultural expressions are entrusted in accordance with the customary law and practices of that community; "

## HOLDERS AND OWNERS OF TK/TCE'S



- Present generations are not considered the owners, but rather the custodians and administrators, of the collective knowledge they possess. Therefore, they are not allowed to transfer it to a third party, but only to permit its use through licenses.
- As holders of TK, communities have the right to deny access or to grant and determine the level of access to their collective traditional knowledge.

## HOLDER AND OWNER OF TK/TCE'S



- HOLDER may not be the owner(present generationsallowed to LICENSE
- OWNER is both a holder and an owner- Local and Traditional Communities

### IMPORTANT TOOLS



- Documentation methods- Databases, TKDR
- Contracts, customary laws, authorised user agreements
- Newly developed sui generis regulations and
- Legislation to address the effective protection of TK
   &TCEs

## PRACTICAL INITIATIVES



- Strengthen communities capacity to document,
- Protect, develop, teach and apply all aspects of the communities'heritage and traditional cultural expressions.
- To develop a wide range of education and training opportunities and modules including co-curricula activities in diverse copyright traditional cultural expressions from communities and in the education system.

## CONT'D



- Build the capacity of individuals, communities and national institutions in negotiations and conflict resolution. .
- Encourage the dissemination of copyright and traditional cultural expressions while actively developing mechanisms to acknowledge, protect and benefit the sources of that information.
- Facilitate access by local communities to appropriate information and technology.
- \*Enhance capacity through peer to peer exchanges.

## ASSIGNMENTS AND LICENSES



- Contracts
- Assignments: The owners of traditional knowledge or cultural expressions rights shall have the right to assign and conclude licensing agreements.
- Traditional knowledge or cultural expressions belonging to a local or traditional community shall not be assigned without the authorization of the custodian of the local or traditional community.
- Licenses
- Compensation





- TCE works can be protected by copyright or related rights
- Duration for Copyright: 50 years after the death of the author
- TCE's in perpetuity
- Adaptation of folksong
- Prior authorization of holder is required
- Within the Sui Generis regime
- Misuse, misappropriation must be prevented

## EXCEPTIONS AND LIMITATIONS

- Private and
- Non Commercial use
- Personal use
- Research
- Educational Purposes
- Criticism, review or reporting current events



# WITHOUT PRIOR INFORMED CONSENT/PERMISSION



- the reproduction of the traditional knowledge or cultural expressions;
- the publication of the traditional knowledge or cultural expressions;
- the performance or display of the traditional knowledge or cultural expressions in public;
- the broadcast of the traditional knowledge or cultural expressions to the public by radio, television, satellite, cable or any other means of communication;

## CONT'D



- the translation, adaption, arrangement, transformation or modification of the traditional knowledge or cultural expressions;
- the fixation of the traditional knowledge or cultural expressions through any process, including making a photograph, film or sound recording;
- the availing online or electronic transmission to the public (whether over a path or a combination of paths, or both) traditional knowledge or cultural expressions;
- the creation of derivative works/inspired works; and
- the making, use, offer for sale, sell, import or export traditional knowledge or cultural expressions or products derived there from.

## PROTECTED TK/TCE'S AND COMPULSORY LICENSE

#### SECTION 12 of the TK AND TCEs ACT

• Where protected traditional knowledge is not being **sufficiently exploited** by the owner or rights holder, or where the owner or holder of rights in traditional **knowledge refuses to grant licenses for exploitation**, the Cabinet Secretary may, **without** prior informed consent of the owners, grant a compulsory licence for exploitation subject to Article 40(3) (b) of the Constitution.

## RECOGNITION OF TK HOLDERS/OWNERS

- A person who uses traditional knowledge or traditional cultural expressions beyond its traditional context they shall acknowledge the knowledge,
- indicate the source of the knowledge or expression and where possible,
- the origin of the knowledge or expression, and use such knowledge or expression in a manner that respects the cultural values of the holders.



## AUTHORIZED USER AGREEMENTS RIGHTS HOLDER AND AUTHORIZED USER



- a benefit sharing arrangement that provides for fair equitable monetary or nonmonetary compensation to the right holders;
- provide for identification and disclosure of the traditional knowledge or cultural expressions on which the derivative work based by mentioning the holders or the geographical place from which it originated; and
- state that the traditional knowledge or cultural expressions in the derived work will not be subject to derogatory treatment.

### CONT'D



- The Authorized User Agreement involves some kind of bilateral approach or negotiation between a user and an indigenous peoples' representative.(Consultations)
- TK-related policies and instruments include registers as a tool to support protection measures, whether defensively or to positively help in assigning rights to indigenous peoples. EXAMPLE the Traditional Knowledge Digital Library (TKDL) initiative in India, among others.

## MANAGEMENT OF RIGHTS



- The owners of traditional cultural expressions may-:
- grant authorization for the exploitation and use of expressions their traditional knowledge and cultural expressions; or
- after necessary consultations, authorize the Government or any other person to exploit their traditional knowledge and cultural expressions

## CONT'D



- the relevant **community is identified as the source of any work** or other production adapted from the cultural expressions;
- any distortion, mutilation or other modification of, or other **derogatory action in** relation to cultural expressions can be prevented;
- any false, confusing or misleading indications or allegations which, in relation to goods
  or services that refer to, draw upon or evoke the cultural expressions of a
  community or suggest any endorsement by or linkage with that
  community;
- where the use or exploitation is intended to be gainful, equitable remuneration or benefit-sharing, the use or **exploitation is on terms determined and agreed** with the relevant community and in the absence of such agreement as determined by the **Cabinet Secretary in consultation with the relevant community.**

# COLLECTIVE MANAGEMENT OF COPYRIGHT AND RELATED RIGHTS

- Done on behalf of the Rights Owners
- Rights of Performers-in their performances of copyright works and folklore
- Rights of Producers
- Rights of Broadcasting Organizations-
- Exclusive rights for economic benefit

### SCOPE OF PROTECTION RIGHTS OF TK HOLDERS

Every community shall have the exclusive right to:

- authorize the exploitation of their traditional knowledge' knowledge;
- prevent any person from exploiting their traditional knowledge without their prior informed consent.
- the owners shall have the right to institute legal proceedings against any person who exploits traditional knowledge without the owner's permission.
- Every community shall make and adopt its community rules prescribing the procedures for the authorization of the exploitation of their traditional knowledge.



## REGISTRATION MODEL NO FORMALITY



- Register cultural expressions within the **respective counties** for the purposes of recognition.
- The **registration shall be undertaken willingly** by the owners of cultural expressions upon obtaining prior informed consent but shall not require the public disclosure of the cultural expressions concerned.

## CONT'D



- Where more than one community in the same or different counties share the same cultural expressions, respective country governments shall register the owners of the cultural expressions and maintain relevant records.
- Where concurrent claims arise from different communities, national government or county government shall while determining the claim consider customary law and protocol of the communities in question, local information sources and any other means that may be applicable.
- Registration shall have a mere declaratory function and shall not in itself confer rights.
- Cultural expressions shall be protected against all acts of misappropriation, misuse, unlawful access or exploitation for as long as the cultural expressions fulfill the protection criteria

## SANCTIONS AND REMED



- possession;
- >manufactures,
- >produces or
- makes in the course of trade;
- > sells, barters or exchanges,
- > offers or exposes for sale, disposes, distributes, hires out;
- Criminal Offences-Fines \$20,000,10 years imprisonment etc
- ➤ Civil Remedies- compensation, declaration, public apology etc

## OTHER MECHANISMS TO RESOLVE DISPUTE



- Mediation;
- Alternative dispute resolution procedures;
- Customary laws, practices and protocols not inconsistent with the Constitution.

### REGULATIONS



- administrative requirements necessary for the implementation of the provisions of this Act;
- the **procedure** for applications of authorization for the exploitation of traditional knowledge and cultural expressions;
- fees to be paid
- mechanisms for fair distribution of benefits derived from usage of traditional knowledge and cultural expressions;
- preventive mechanisms aimed at protecting traditional knowledge and cultural expressions;
- forms to be used for matters requiring forms under this Act; and
