Legislative initiatives


- ▶ NO specific indigenous aspect in IP legislation (EU position)
- UNESCO Convention on Safeguarding of Intagible Cultural Heritage, 2003
 - National implementation via National Heritage Agency, 2013
 - Sámi representation challenging, cross-border issues
 - ▶ Unesco ICH Conference in Karasjokk 2019 \rightarrow Pan-Sami ongoing
- Nagoya Protocol on Access and benefit sharing 2010
 - ► Genetic Resources Act, 2016 one Sámi representative
 - MAT on ABS between Sámi and the users resource or product development – subject to confirmation by authority
- ▶ DISNEY Frozen 2 movie-case $2019 \rightarrow$ more awareness
 - ▶ Will be discussed in 2021

Best approach is the indigenous point of view – A DIALOGUE

- Legal context status recognized (self determination, participation)
 - Constitution (in Finland, Sweden and Norway)
 - Act on Sami Parliament "Obligation to negotiate" issues that impact Sámi languatge and culture
- Practical application challenging
 - Concrete examples
 - Gákti, Sami duodji, Yoik (yoik, livvde, leu'dd), traditional livelihoods, names, symbols
- DIALOGUE between government and indigenous people (UNDRIP 31 article)
- Experts from indigenous people
 - Three Presidents of the Sámi Parliaments and the Sámi Council = SPC Sami Parliamentary Council
 - Practical workshops on Sámi ICH, WIPO practical workshops on Intellectual Property

- Conference on the Protection of Nordic Indigenous TK&IP on 11 Nov 21
 - Study 2018 "Needs of the Sámi for IP protection...", FPIC of Sámi
 - Virtual expert seminar 2020 all different points of views
 - Portal of Dialogue: Open web portal on discussions towards NCM Conference
- IMKÀS study 2021
 - pre-study of the Pan-Sámi view a RIGHTS BASED APPROACH
- CONCRETE EXPERIENCES ON EXISTING SYSTEMS
- WIPO practical workshop on TK
 - ▶ To address the outcomes from the Conference
