The Cree Native Arts and Crafts Association (CNACA) is a non-for-profit organization established in 2004 under the James Bay and Northern Quebec Agreement (JBNQA) signed in 1975. Our mandate is to assume a leadership role on behalf of the Cree for the development of the arts and crafts and the cultural industries of Eeyou Istchee. CNACA is a resource hub that links arts and crafts entrepreneurs with the resources to assist them to succeed and thrive in their business. We develop and encourage educational and funding programs to assist the membership to maximize their potential, as well as foster and encourage networking within the arts and craft industry.

Main aims and objectives of the Organization:

- Our vision and work are guided by four pillars:
 - Our artists and craftspeople are living bearers of our culture and heritage.
 - Our arts and crafts are the expression of our past, our present and our aspirations for the future.
 - Our artists and artisans must be able to sustain themselves economically through their talents.
 - As long as Cree arts and crafts are maintained, and our traditions preserved; our Cree people will remain strong.
- Our objectives:
 - Develop and be responsible for programs that contribute to the development of the Cree arts and crafts industry in Eeyou Istchee.

CNACA (Cree Native Arts and Crafts Association) is deeply engaged in issues surrounding intellectual property (IP) as they relate to traditional knowledge and cultural expressions. As a not-for-profit organization representing Cree artists and artisans, we work to protect the integrity of Indigenous cultural heritage and ensure creators are empowered through both education and advocacy. Many of our members rely on orally transmitted, collectively held knowledge that falls outside conventional IP protections. CNACA is interested in WIPO's work because international guidance and reform are essential to address gaps in existing frameworks, particularly in protecting Traditional Knowledge (TK) and Traditional Cultural Expressions (TCEs). We support efforts that integrate UNDRIP principles, promote respect for Indigenous laws, and ensure fair benefit sharing. Our goal is to safeguard Cree culture from misappropriation while creating sustainable opportunities for our artists. CNACA aims to contribute a Cree perspective to WIPO's global discussions.

CNACA represents over 900+ Cree artists and artisans across Eeyou Istchee. We regularly collaborate with legal experts, Elders, and cultural practitioners to ensure that IP education and advocacy reflect traditional values and community protocols. In 2024, we launched a public education initiative on IP and Traditional Knowledge to build awareness and support grassroots protection. CNACA is also working toward developing culturally relevant IP policies that center Cree law and community governance. Participation in the WIPO IGC will strengthen our

capacity to advocate for international standards that recognize Indigenous worldviews and enable communities to retain control over their cultural expressions.

Métis Legal Research & Education Foundation, Inc.

The Foundation is a not-for-profit organization which was formed in 2001 to carry on the work of advancing the recognition of Métis Nation Aboriginal rights, as protected by the S35 Canadian *Constitution Act, 1982*. The Foundation's mandate is to conduct research, public education, publishing, lectures, workshops, advocacy, human rights research and advocacy and appear before government hearings, commissions, tribunals and courts of law for the betterment and advancement of the rights and well-being of the Métis people. The Foundation is governed by a Board of Directors which consists of Aboriginal representatives from across the province within Canada. The Foundation operates primarily by the pro bono legal services of various lawyers and where possible through paid contracts to professional services contractors.

- to conduct human rights and legal research
- to undertake public education through workshops and lectures on pressing legal matters facing Indigenous Peoples
- to publish materials online and in print for the dissemination of Foundation products to promote community capacity development
- to advocate on behalf of Indigenous communities or citizens to advance their human or Indigenous rights with governments, industry, private corporations or public corporations and in courts or tribunals.

- prepare research and information publications to advance and advocate for those perspectives which advance informed decision making on matters affecting Métis peoples, inclusive of all genders and ages and socio-economic situation

Relationship of the Organization with intellectual property matters, including a full explanation of why you are interested in the issues under discussion by the Committee (Maximum 150 words)

The Foundation, through its board members, often attending in other capacities, has been involved with WIPO since IGC 5 where representation of our board participated in the dialogues

in WIPO being funded under the Voluntary Fund. We have been following WIPO all the way to the finalization of the treaty in 2024. We have focused significant attention to Indigenous knowledge systems, advancing Métis traditional knowledge, cultural knowledge and systems in numerous courts and arenas. The protection of Métis traditional knowledge is an ongoing struggle as industry and government advance economic priorities and interfere with the ongoing relationship of Métis and other Indigenous peoples' access to their traditional resources, genetic resources and associated TK. Patent systems do not have adequate access to TK to include TK in their assessments. Work must be done to create meaningful partnerships to promote, disclose and protect TK in patents generally.

The Foundation is committed to provision of education and information to various agencies including Indigenous communities and non-Indigenous communities to better appreciate the subject matter (TK, TKAGR, TCE) under the WIPO Treaty and to assist in the exploration and dialogue on solutions to advance access to TK and to support Indigenous peoples to store, protect and inure benefit from the sharing of their knowledge with others. The Foundation is also committed to the exploration of possible mechanisms and tools in information sharing systems that would protect the knowledge while allowing communities to share appropriate knowledge with patent offices. Our board members have undertaken significant number of TK studies on land use of Indigenous peoples and presented at international CBD programs and on panels, including at the World Summit on Sustainable Development, and give advice within Commission for Environmental Cooperation on TK Engagement in Canada/US/Mexico.
