Film Register Treaty (FRT) Union

First Session (1st Extraordinary) (Geneva, February 27 and 28, 1991)

The Assembly of the Union for the International Registration of Audiovisual Works (Film Register Treaty (FRT) Union) held its first session (1st extraordinary) at the headquarters of W1PO on February 27 and 28, 1991*.

The following five States are members of the Assembly and were represented at the session: Austria, Burkina Faso, Czechoslovakia, France, Mexico. The following States were represented by observers: Brazil, Chile, Hungary, India, Soviet Union. The following non-governmental organizations were also represented by observers: Association for the International Collective Management of Audiovisual Works (AGICOA), International Association of Audio-Visual Writers and Directors (AlDAA), International Confederation of Societies of Authors and Composers (CISAC), International Federation of Associations of Film Distributors (FIAD), International Federation of Film Producers Associations (FIAPF), International Federation of the Phonographic Industry (IFPI). The list of participants follows this note.

The Assembly elected as Chairman Mr. Christian Zeileissen (Austria) and as Vice-Chairmen Mr. André Roch Palenfo (Burkina Faso) and Mrs. Hélène Raymondaud (France).

The Assembly adopted its Rules of Procedure and decided about the admission of observers to this and future sessions of the Assembly. Also, it adopted the program and budget of the Union for the rest of the year 1991 as well as the financial regulations of the Union. Switzerland was designated as auditor of the accounts of the Union up to

The Consultative Committee held its first session immediately after its establishment and gave its advice on proposed amendments to the Regulations under the Treaty and on the draft Administrative Instructions including the draft Schedule of Fees and draft Forms prepared by the Director General. (Those Administrative Instructions shall, according to Rule 9(2) of the Regulations, be drawn up, and be modified by the Director General after consultation of the Consultative Committee.)

Following the meeting of the Consultative Committee, the Assembly adopted the proposed amendments to the Regulations, which are reproduced in Annex I to this Note.

The Assembly decided, as provided for in Article 5(3)(a)(vii) of the Treaty, to establish a Consultative Committee consisting of representatives of interested non-governmental organizations and determined the initial membership of that Committee and adopted its Rules of Procedure. The initial members of the Consultative Committee are: American Film Marketing Association (AFMA), Association for the International Collective Management of Audiovisual Works (AGICOA), European Broadcasting Union (EBU), European Federation of Audiovisual Filmmakers (FERA), Independent Film Producers International Association (IFPIA), International Association of Audio-Visual Writers and Directors (AIDAA), International Bureau of Societies Administering the Rights of Mechanical Recording and Reproduction (BIEM), International Confederation of Societies of Authors and Composers (CISAC), International Federation of Associations of Film Distributors (FIAD), International Federation of Film Producers Associations (FIAPF), International Federation of the Phonographic Industry (1FP1), Sovexportfilm (SEF).

The Assembly decided that the date of the commencement of the operation of the International Film Register be September 1, 1991.

ANNEX I

Amendments to the Regulations Under the Treaty Adopted by the First Session (1st Extraordinary) of the Assembly of the Film Register Treaty (FRT) Union

Rule 1(vi) of the Regulations under the Treaty on the International Registration of Audiovisual Works (hereinafter referred to as "the Regulations") is amended to read as follows:

"(vi) 'person-related application' means an application that describes one or more existing or future work or works, not identified by its or their title or titles, at least by indicating the natural person who or legal entity which has made, or owns, or is expected to make or own, the work or works, and requests that statements in respect of the interest of the applicant, or of a third person identified in the application, be registered in the International Register; 'person-related registration' means a registration effected pursuant to a person-related application;"

 A new Rule, numbered 1bis, is inserted in the Regulations after Rule 1. It reads as follows:

"Rule 1bis: Eligibility in the Case of Several Applicants

"Where more than one natural person or legal entity files the same application, the requirements specified in Article 3(5)(a) of the Treaty shall be considered as fulfilled if any of them is entitled to file an application under the said Article."

- 3. Rule 2(4) of the Regulations is amended to read as follows:
 - "(4) [Name and Address of Certain Third Persons Referred to in the Application] Where an application refers to a natural person or legal entity, other than the applicant, from whom or from which a right of exploitation is derived, or to whom or to which such a right is assigned, licensed or otherwise transferred, the application shall indicate, as prescribed, the name and address of such person or entity."
- Rule 2(5)(b) of the Regulations is amended to read as follows:
 - "(b) Any person-related application shall describe the work or works in which the applicant has an interest. It shall do so by at least indicating the natural person who or the legal entity which has made or owns, or is expected to make or own, the work or works."
- Rule 2(13) of the Regulations is amended to read as follows:
 - "(13) [Fees] For each application, the applicant shall indicate the prescribed data necessary for the calculation of the fee and pay the prescribed fee, which must reach the International Registry not later than the day on which the application is received by the International Registry. If the prescribed data necessary for the calculation of the fee is communicated to the International Registry and the prescribed fee reaches the International Registry within 30 days from

the date on which the application was actually received by the International Registry, the application shall be considered as having been received by the International Registry on the date on which the prescribed data necessary for the calculation of the fee had been communicated to the International Registry and the prescribed fee has reached the International Registry, whichever occurs later."

- 6. Rule 7(4) of the Regulations is amended to read as follows:
 - "(4) [Monitoring Service] The International Registry shall, against the payment of the prescribed fee, give written information, promptly after each registration is effected,
 - (i) on all registrations effected in respect of a given work;
 - (ii) in respect of all registrations that concern a given natural person or legal entity, provided that it is the person or entity concerned, or a third person authorized by the person or entity concerned, who or which requests such a service."
