Ratification

INDONESIA

The Government of Indonesia deposited, on September 18, 1979, its instrument of ratification of the Convention Establishing the World Intellectual Property Organization (WIPO), signed at Stockholm on July 14, 1967.

The WIPO Convention will enter into force, with respect to Indonesia, on December 18, 1979.

Ratification of the Stockholm Act (1967) (with the exception of Articles 1 to 12)

INDONESIA

The Government of Indonesia deposited, on September 18, 1979, its instrument of ratification of the Stockholm Act of July 14, 1967, of the Paris Convention for the Protection of Industrial Property of March 20, 1883, with a declaration to the effect that its ratification shall not apply to Articles 1 to 12.

Furthermore, the said instrument of ratification contains the following reservation: "the Republic of Indonesia takes the position that for any dispute to be referred to the International Court of Justice for

decision, the agreement of all the Parties to the dispute shall be necessary in each individual case."

Indonesia will belong to Class VI for the purpose of establishing its contribution towards the budget of the Paris Union.

The Stockholm Act (1967), with the exception of Articles 1 to 12, will enter into force, with respect to Indonesia, on December 20, 1979.
