

# WIPO-ASEAN Mediation Programme (AMP+)

As part of the collaboration between WIPO and ASEAN under the WIPO-ASEAN Memorandum of Understanding, ASEAN parties can benefit from the WIPO-ASEAN Mediation Programme (AMP+).

**AMP+** offers funding for intellectual property, commercial, and technology-related mediations administered by the WIPO Arbitration and Mediation Center's (**WIPO Center's**) Office in Singapore.

## Funding covers two types of situations:

- Mediation for Disputes:** Funding is provided for cases where parties are involved in an IP or technology dispute.
- Deal Mediation:** Funding is also available to facilitate contract or licensing negotiations where parties cannot agree on contractual terms.

Funding for both mediation types administered by the WIPO Center is available to Parties according to the following schedule of fees:

Type of Case	Funding Amount	Administration Fee
Any existing IP/technology negotiation or dispute involving a party who is an ASEAN national or entity	Up to SGD 5,000*	Waived
<i>Where a Singapore-based mediator is appointed, the Intellectual Property Office of Singapore (IPOS) makes available additional funding of up to SGD 2,000.</i>		
<i>(*) The maximum amount of SGD 5,000 (or SGD 7,000 where a Singapore-based mediator is appointed) to be funded by the AMP+ will first cover the mediator's fees, and any remaining balance may be applied towards parties' legal fees or, for unrepresented parties, other mediation-related expenses. Reimbursement is available upon compliance with the AMP+ conditions and submission of the relevant invoices</i>		

# WIPO-ASEAN Mediation Programme (AMP+)

## Conditions

- Parties may apply for funding under AMP+ until December 31, 2026 or until the AMP+ fund is drawn down, whichever is earlier.
- At least one party must be an ASEAN national or entity (the ASEAN Member States are Brunei Darussalam, Cambodia, Indonesia, Lao PDR, Malaysia, Myanmar, Philippines, Singapore, Thailand, Timor-Leste and Vietnam).
- The mediator must be based in an ASEAN Member State.
- Parties must provide feedback on the mediation experience.
- Parties must consent to named publicity (excluding details of settlement terms).
- A shadow mediator may be appointed to observe the mediation.
- Parties appointing a Singapore-based mediator may not claim both under AMP+ and under the **Revised Enhanced Mediation Promotion Scheme (REMPs)** for costs in relation to the same or substantially the same dispute.

# Frequently Asked Questions

## 1. Is there a time limit on the availability of AMP funding?

- To be eligible for funding under AMP+, a Request for WIPO Mediation and the request for AMP+ funding must be made to the WIPO Center before December 31, 2026. Funding under AMP+ will be available during that period or until the AMP+ fund is drawn down, whichever is earlier.

## 2. Where can the mediation be held?

- The mediation can be held online or in person anywhere, as long as an ASEAN-based mediator is appointed.

## 3. Must the mediation be successful for funding to be disbursed?

- No, parties can apply for funding under AMP+ as long as they have participated in the mediation, regardless of the outcome of the mediation.

## 4. How do I apply for AMP+ funding?

- When you submit your Request for WIPO Mediation to the WIPO Center, please inform the WIPO Center that you would also like to apply for AMP+ funding. The WIPO Center will then provide further guidance regarding the conditions of AMP+ funding.

## 5. How will AMP+ funding be provided?

- Parties will be reimbursed up to SGD 5,000 for each mediation case. Each party can potentially claim an equal share of up to SGD 2,500 (assuming two parties), unless otherwise agreed.
- Where a Singapore-based mediator is appointed, IPOS will fund an additional SGD 2,000, to be split equally among the parties.
- Reimbursement under AMP+ will first cover the mediator's fees, and any remaining balance may be applied towards parties' legal fees or, for unrepresented parties, other mediation-related expenses. Reimbursement is available upon compliance with the AMP+ conditions and submission of the relevant invoices

## 6. Is AMP+ funding limited to disputes?

- No, parties may also utilise funding for "deal mediation" which refers to a mediation in which the mediator assists the parties in concluding an agreement. For example, such mediations may be appropriate in the context of ongoing patent licensing negotiations.
