<sup>1</sup> According to Paragraph 7.2 of the .SE Policy, a name is "a trade symbol (trademark or service mark); a trade name or secondary name; a family name; an artist's name (if the name is not associated with someone who deceased a long time ago); a title of another party's copyrighted literary or artistic work; a name that is protected by the Regulation concerning Certain Official Designations (1976:100); or the name of a government authority that is listed in the registry that Statistics Sweden must maintain under the Swedish Code of Statutes SFS 2007:755 (Government Agencies Register Ordinance), or its generally accepted abbreviation".
