

## **CWS XML4IP Task Force Meeting**

**Alexandria, USA, 26-30 October, 2015**

### **MEETING REPORT**

#### **INTRODUCTION**

1. The XML4IP Task Force meeting took place in Alexandria from 26 to 30 October 2015. The following six offices/organizations were represented at the meeting: CA, EM, GB, KR, US, and WIPO (IB). The meeting agenda was adopted as proposed by the International Bureau of WIPO (IB) and is reproduced along with the delegations list as an Annex to this report.

2. The meeting was opened by Ms. Sharon Marsh, Deputy Commissioner for Trademark. She emphasized the importance of our work with WIPO and work on Trademarks around the world with emphasis on information exchange, information gathering, and translation to native languages.

3. Mr. Yun, as Task Force Leader, chaired the meeting. The delegations would like to extend their most sincere thanks to the USPTO for the excellent hospitality and support they made available for the Task Force meeting.

#### **DISCUSSIONS, CONCLUSIONS AND AGREEMENTS**

##### ***Agenda Item 2: Adoption of the Agenda***

4. The IB explained that the purpose of the meeting was to prepare the next version of ST.96 and the importance of the work on the Madrid and Hague XML schemas.

6. The agenda was adopted as proposed and is attached to this report.

##### ***Agenda Item 3: Progress Report by Task Force Leader***

7. The Task Force Leader delivered a progress report on the development of ST.96 since the XML4IP Task Force meeting held last year in London. He highlighted activities of the Task Force, according to the Task Force Work Plan 2015, to complete the task assigned by the CWS, i.e., revision of ST.96 and preparation of the pending Annexes V and VI. The Task Force approved the revision of ST.96 version 2.0 and prepared the Annexes V and VI for consideration and adoption

by the CWS. The TF Work Plan is available at the TF e-forum Wiki at:

8. The Task Force Leader reminded the delegations of the remaining tasks in the TF Work Plan 2015 for future development of the following additional schemas listed below:

- Search report
- Written opinion
- PCT Forms (Request and other forms)
- Transaction
- Amendment
- Priority document
- Legal Status Data

9. The Task Force Leader updated the delegations with news from the TF members' Offices who could not attend the meeting. The IB was informed that the EPO was studying the feasibility as to whether it could consume and produce patent data in ST.96 format; the NIPO plan to use ST.96 for payment and for renewals; ROSPATENT have already started using ST.96; and the UPOV developed PVP-XML based on ST.96 version 2.0.

10. The Task Force Leader reported that two minor mistakes were found in version 2.0, which were posted in the TF e-forum as IssueID-572. He hoped that these would be resolved in the next version of ST.96. He reminded the delegations that many open issues are under discussion.

11. The Task Force Leader reported the status of work on identifying unknown country codes to be included in ST.3. There was no consensus on the initial proposal by the USPTO. Now the USPTO and the JPO are working on a draft on a new proposal.

12. The Task Force Leader reported the current situation of the CWS and hoped the Member States would agree on the pending matters soon to resume the adjourned 4th session of the CWS in the first quarter of 2016. The IB may organize a workshop on WIPO Standard in 2016 to discuss some outstanding issues, e.g., Legal Status and person name standardization.

13. The Task Force Leader reminded delegations of the UK IPO's proposal on online filing and renewal which requires changing SD-02 in Annex I. In order to address this issue, he presented an idea and suggested restructuring ST.96 to separate transaction or transmission level schema components from the current ST.96 which mostly contains component level. He said that the IB would create a new issue to continue discussion this matter.

Action: The IB to create a new issue in the Issue Register to discuss the restructure of ST.96.

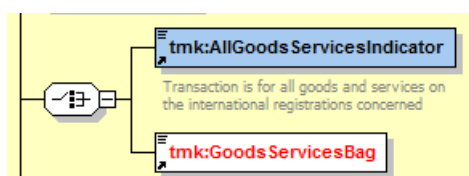
#### ***Agenda Item 4: Development of ST.96 XML schema components for Madrid System communication***

14. Delegations noted a general issue on how to distinguish Madrid specific components to avoid naming conflicts with the components already in the ST.96 trademark namespace since the Madrid components should go under the ST.96 namespace "tmk". It was agreed to add "Madrid" as the object class term to all document/transaction level components and any lower level components if needed.

15. There are description mismatches between the Madrid mapping spreadsheet and the XML. Please see the component names and agreed descriptions below.

- (a) MadridGoodsServicesLimitationRequest: Agreed description: "Limitation of goods and services which are applicable to the given designated contracting parties. Office of Origin or Designated Office" [Note: It was agreed to add the language "office of origin" and/or "designated office", in the description of Madrid transaction-level components where applicable.]
16. MadridGrantProtection: Agreed description: Statement of Grant of a trademark where no notification of provisional refusal has been communicated. Designated Office.
17. OfficeSpecificContent:
- (a) Agreed description: Office specific data that could be used to format styled information or any other special needs.
- (b) Agreed decision: Move OfficeSpecificContent to common from Madrid and Hague.
18. ProposedMarkTranslation: Agreed description: Proposed translation for goods and services
19. com:PaymentDueDate: Agreed description: Date by which a payment must be received
20. MadridNationalRegistrationReplacement
- (a) Agreed description: Notification of replacement of national or regional registration. Designated Office.

36. Based on its current practice, KIPO proposed to

- (a) Add com:InternationalRegistrationDate
- (b) Add MailDate which indicates a date of notification

Agreed decision: It was recommended to use RecordNotificationDate, instead of MailDate,

Agreed decision: It is recommended for KIPO to use OfficeSpecificContent to hold this information CIPO indicated that RecordNotificationDate may be needed. The KR proposal should be further discussed to identify appropriate components even though they would not be included in MadridOfficeToIB.

*(TRANFI) FinalPartialGrantProtection*

37. KR proposed to add MailDate which indicates a date of decision

Agreed decision: It is recommended for KIPO to use OfficeSpecificContent to hold this information

*(TRANFI) FinalTotalRefusal*

38. KR proposed to add MailDate which indicates a date of final decision

Agreed decision: It is recommended for KIPO to use OfficeSpecificContent to hold this information

*(TRANGP) MadridGrantProtection*

39. KR proposed to

- Add com:InternationalRegistrationDate
- Add MailDate which indicates the date granted of protection not mail date. KIPO provide data from paper copy to IB.

Agreed decision: It is recommended for KIPO to use OfficeSpecificContent to hold this information

Action: USPTO to confirm this date and report

Note: There is also DecisionDate and it may not be the date protection is granted per CIPO and IB.

42. The IB stated there is a need to specify components needed by the IB and identify components not need by the IB. KIPO sends XML data and also PDF files; the IB does not care about the reasons but some IP Offices provide the reasons. The IB receives TIFF, MS-Word, PDF and they are passed through the customer. OfficeSpecificContent can be a content model to capture additional information needed by an IP office, not needed by the IB. CIPO indicated that adding the IP Office to the IB XML schema should only contain components the IB needs.

Agreed decision: It is recommended for KIPO to use OfficeSpecificContent to hold this information

56. TotalInvalidation, PartialInvalidation: Combined into one element called MadridInvalidation with a choice between AllGoodsServicesIndicator and GoodServicesBag. The IB explained that it provides a history of events of a trademark and helps with statistics and reporting. It does not have details of a full transaction.

57. TotalCeasingEffect, PartialCeasingEffect: Combined into one element called MadridCeasingEffect with a choice between AllGoodsServicesIndicator and GoodServicesBag.

58. It was agreed to apply the same combining concept to all other components which have partial and total content models.

59. ProvisionalRefusal

- (a) Agreed description: tmk:GoodsServicesRefusalCategory: Goods and services which are refused or accepted
- (b) Agreed decision: Replace tmk:GoodsServicesBag with tmk:GoodsServicesRefusalBag

60. MadridGenericOfficeCommunication (TRANXX) – used by offices that cannot create proper XML for a given transaction, but would like to communicate electronically with the IB. For example, an Office sends transaction that says this is a refusal for a trademark and here are the documents. The minimum information is International Registration number and type of transaction and the content that is defined in TRANXX. This transaction is used when a dedicated transaction cannot be produced. OHIM explained for example, LimitationHasNoEffect cannot be produced by their IT system, so a generic transaction would be used instead; XX can support all types of transactions. Smaller IP Offices may not be able to use dedicated transactions and thus use TRANXX. IB states of course that use of the dedicated transaction types is preferred. Use of GenericTransaction does not provide all the benefits of using dedicated transactions.

- (a) Agreed decision: Rename TRANXX to MadridGenericOfficeCommunication.
- (b) Agreed description: TRANXX: Generic communication to allow IP Offices to send to the IB when dedicated transactions cannot be used or have not yet been defined. Office of Origin or Designated.
- (c) Add Optional com:FileName before DocumentIncludedBag

- (d) Place the optional element OfficeSpecificContent before CommentText
- (e) MadridGenericOfficeCommunicationCategory is expanded to include all possible options for total and partial invalidation. For example, in the enumeration value we need Invalidation, Partial invalidation, and Total invalidation.

### ***Agenda Item 7: Discussion on Supplementary Protection Certificates (SPCs)***

124. The discussion was based on the proposal from the UK IPO regarding SPC posted in the TF e-forum at: <https://www3.wipo.int/confluence/display/xml4iptf/IssueID-575>. The UK IPO proposed to develop XML schema for Supplementary Protection Certificates (SPC) to facilitate SPC data processing in the IPO and data exchange among IPOs. This is an IP right that extends the duration of certain rights associated with a patent. It enters into force after expiry of the patent upon which it is based. This type of right is available for various regulated, biologically active agents, namely human or veterinary medicaments and plant protection products (e.g. insecticides, and herbicides). A supplementary protection certificate comes into force only after the

corresponding general patent expires. It normally has a maximum lifetime of 5 years. The duration of the SPC can, however, be extended to 5.5 years. All countries in EU have this same practice. It was informed that SPC implementation at UK IPO is approximately one year away.

The UK IPO proposed adding a new document level Design Bibliographic element for the storage of Designs data. It was stated that the UK IPO would implement DesignBibliographicData in 2016 once they move off their Mainframe system scheduled to be before November 2016.

127. The delegations agreed to rename DesignBibliographic to DesignBibliographicData.

IssueID-572 – WIPO ST.96 V2 0 errors

133. The IB reminded the delegations of two minor errors found in the ST.96 version 2.0 and proposed to correct the following errors as suggested in the next version of XML Schema.

- (f) Error 1. Name conflict between components defined in Common and Patent  
com:figureNumber, Pat:FigureNumber  
Error 2. Same description for the different components
- (g) com:InternationalRegistrationDate (The date of publication by the International Bureau of an international registration of an industrial design.)
  - (i) action: IB will confirm description above
- (h) com:InternationalRegistrationPublicationDate (The date of publication by the International Bureau of an international registration of an industrial design.)
  - (i) IB confirmed above description.

Action: USPTO to post other issues on the WIKI.

134. While awaiting any suggestion on the first error, the IB suggested the revised text regarding the 2nd error below for discussion at the meeting. The TF meeting requested the IB to further study to find more appropriate definitions for the two components according to the Madrid and Hague system regulations.

(a) com:InternationalRegistrationDate (The date that the IPR is registered by the International Bureau)

(b) com:InternationalRegistrationPublicationDate (The date that the IPR is published by the International Bureau)

Action: IB to provide more appropriate definitions for the two components according the Madrid and Hague system regulations.

#### Issue/D-573 – UPOV proposal

135. The UPOV proposes to add a new value “Breeder” to the enumeration value of com:SignatoryCapacityCategory based on com:RoleCategoryType. The delegations agreed to add the new permissible value “Breeder” to the component.

#### **Agenda Item 10: Work plan 2016**

136. The delegations discussed the work plan for 2015 and 2016. It was agreed that the XML4IP TF would review and comment on, by November 20, 2015, draft XML schemas of Madrid and Hague developed at the meeting and organize an online conference through WebEx on November 24, 2015.

Action: the IB to post the revised schemas and send an invitation to the upcoming WebEx meeting.

137. The USPTO and the CIPO shared their plan to implement ST.96 for Madrid and Hague systems

(a) USPTO: current development is using MECA EN transaction because ST.96 was not ready when the project was started. USPTO is proposing to begin with Madrid Application based on WIPO ST.96 and temporarily plan to do this between February 2016 and April 2016. The core system will be based on the MECA DTD, but the USPTO Trademark needs to discuss plans for implementing ST.96 version. USPTO plans to go live with Madrid NG in 2018.

(b) CIPO plans to implement Madrid communications in line with their legislative project schedule which is planned to go live in 2018. CIPO may be able to begin testing some time in 2016, though efforts would have to be in line with the legislative implementation schedule.

(c) The IB proposed to setup a test environment with the USPTO and the CIPO to test communication using ST.96 for Madrid and Hague once the draft schemas are approved by the XML4IP TF for testing. The USPTO and the CIPO agreed that the tests would be helpful and required before going into production.

*Action: the USPTO, the CIPO and the IB to conduct intensive review of the draft Madrid schemas. The USPTO and IB reviews will make use of the current data that they exchange in order to approve the schema. The CIPO is not live with Madrid though they will review the schemas for accuracy. Action: the KIPO, the CIPO and the IB to intensively review draft Hague schemas. The KIPO will review using existing data. The CIPO is not live with Hague though they will review the schemas for accuracy.*
