

Using DAS with the PCT

August 2023

1. INTRODUCTION

In the context of the PCT, the WIPO Digital Access Service (DAS) allows the applicant to request the International Bureau to retrieve an electronic certified copy of an earlier application for use as the priority document in a PCT application, provided that the earlier application was filed with a [DAS Participating Office](#) which deposits the type of document (IP right type) concerned in DAS.

In accordance with [PCT Rule 17.1\(a\)](#), the time limit for the applicant to submit the priority document is “... not later than 16 months after the priority date, provided that any copy of the said earlier application which is received by the International Bureau after the expiration of that time limit shall be considered to have been received by that Bureau on the last day of that time limit if it reaches it before the date of international publication of the international application.” When DAS is used, the applicant may request the International Bureau, prior to the date of international publication, to obtain the priority document from such digital library ([PCT Rule 17.1\(b-bis\)](#)).

The applicant may use DAS to meet the requirement on the submission of the priority document under the [Paris Convention](#) in relation to PCT applications in the following circumstances:

- (i) The earlier application was filed with one of the following DAS participating Offices:¹

For a national application:

Argentina (AR), Australia (AU), Austria (AT), Brazil (BR), Canada (CA), Chile (CL), China (CN), Colombia (CO), Denmark (DK), Estonia (EE), Finland (FI), France (FR), Georgia (GE), India (IN), Iran (Islamic Republic of) (IR), Israel (IL), Italy (IT), Japan (JP), Latvia (LV), Lithuania (LT), Mexico (MX), Monaco (MC), Morocco (MA), Netherlands (NL), New Zealand (NZ), Norway (NO), Poland (PL), Republic of Korea (KR), Spain (ES), Sweden (SE), Türkiye (TR), United Kingdom (GB) and the United States of America (US)

For a regional application: EAPO or EPO

and

The applicant now files a PCT application, which claims the priority of the earlier application.

- (ii) The earlier application is a **PCT application** filed with one of the following PCT receiving Offices:¹

RO/AT, RO/AU, RO/BR, RO/CA, RO/CL, RO/CN, RO/CO, RO/DK, RO/EA, RO/EP, RO/ES, RO/FI, RO/FR, RO/GE, RO/IB, RO/IL, RO/IN, RO/IR, RO/IT, RO/MA, RO/MX, RO/NL, RO/NO, RO/SE and RO/TR

¹ The Offices are listed based on the information available until August 2023. WIPO maintains the DAS Participating Offices related information on the [DAS Participating Offices webpage](#). Using different filters on that webpage, the applicant can always check the latest information including the Offices, the types of documents (IP right types) that an Office deposits in DAS in its capacity as a Depositing Office and/or retrieves from DAS as an Accessing Office.

and

The applicant now files a PCT application, which claims the priority of the earlier PCT application.

2. PROCEDURE FOR USING DAS IN PCT APPLICATIONS

- (i) Request the Office of First Filing (OFF)/Depositing Office to deposit the earlier application in DAS

The specific means for requesting the Office of First Filing, with which the earlier application was filed, to deposit a copy of the earlier application into DAS depend on the requirements of the Office.

The applicant may refer to the [PCT Applicant's Guide](#), Annex B for the procedure to be followed at each DAS depositing Office (see item "is the Office prepared to allow applicants to make applications available to the WIPO Digital Access Service for Priority Documents (DAS) (PCT Rule 17.1(b-bis)?"), or contact the Office directly.

Relevant information may also be found on the Office's website and/or in the notifications on the [WIPO DAS webpage](#).

- (ii) Receive the DAS access code for the earlier application

The DAS code will be provided by the International Bureau through an e-mail sent from noreply@wipo.int if the earlier application was filed with one of the following Offices:

AR, AU, AT, BR, CA, CL, CO, DK, EA, EE, ES, FR, GB, GE, IB, IL, IN, IR, IT, LT, LV, MA, MC, MX, NL, NO, SE and TR.

The DAS code will be provided by the Office of First Filing itself if the earlier application was filed with CN, EM, EP, FI, JP, KR, NZ or US.

For EP and US applications, the access code will be indicated on/provided together with the electronic acknowledgment receipt of the earlier application.

This unique access code allows the applicant to authorise participating intellectual property offices to retrieve a certified copy of the present application (as priority document) via WIPO DAS. The code will only be valid if the requirements for according a date of filing are met (see OJ EPO 03/2019).

(iii) Request the International Bureau to retrieve the earlier application from DAS²

- At the time of filing the PCT application

When filing using ePCT (<https://pct.wipo.int>), in the Priority section, the applicant can select the option “International Bureau to obtain from a digital library [DAS]” provided that the earlier application has already been deposited in DAS.

The DAS code must be indicated. There is a real-time check in ePCT against DAS system to validate the priority related data and that the priority document is indeed available in DAS for retrieval.

² A PCT application deposited in DAS may also be claimed priority in a national or regional application filed with an Office which retrieves PCT applications from DAS. In this case, the DAS retrieval request should be submitted to that Office instead of the International Bureau. The applicant needs to check with the Office concerned for the procedure on how to submit such a request.

► After filing the PCT application

The DAS request can also be made via ePCT after filing. If you have access rights to the PCT application concerned as an eOwner or an eEditor, you can log in ePCT with strong authentication to use the ePCT online action “[Obtain priority document from DAS](#)”. This fully automated ePCT action also verifies the DAS code and cross-checks the priority data.

If you don't have access rights of the PCT application concerned in ePCT, you can provide the DAS code to the International Bureau by submitting a “General Correspondence” using the [Upload Documents](#) function or by sending an [ePCT Message](#).

(iv) Receive confirmation of the submission of a priority document

Upon successful retrieval of the document from DAS, the International Bureau will confirm the receipt of the priority document for the PCT application concerned via Form PCT/IB/304.

3. REQUEST TO MAKE A PCT APPLICATION AVAILABLE IN DAS

When using ePCT to prepare a PCT application with the following receiving Offices: RO/AT, RO/AU, RO/BR, RO/CA, RO/CL, RO/CO, RO/DK, RO/EA, RO/EP, RO/FI, RO/GE, RO/IB, RO/IL, RO/IN, RO/IR, RO/IT, RO/MA, RO/MX, RO/NO, RO/SE or RO/TR, you can request the Office to make available the PCT application in DAS by checking the box: “The receiving

Office is requested to make this international application available to the Priority Document Access Service (DAS)".³

To make such a request after filing, only if the Office is **RO/IB**, the applicant can use the ePCT action "[Make international application available to DAS](#)" or by means of a letter, preferably uploaded via ePCT.

Once the earlier application is registered, RO/IB will send the DAS access code via PCT/RO/132 to the applicant/agent.

4. IMPORTANT INFORMATION ON USING DAS WITH US APPLICATIONS

National US patent applications are automatically deposited in DAS by the USPTO after filing. If the applicant doesn't intend to register such an application in DAS, please refer to [Opt-out of DAS with the USPTO](#). In case the applicant has requested to opt out the earlier application from DAS, the applicant may afterwards request the USPTO to "opt in" the application to DAS by filing the Form PTO/SB/39.

Even though the DAS code (confirmation number) is provided at the time of filing on the electronic acknowledgement receipt, it does not mean that the application is registered in DAS. It may take up to several weeks for the USPTO to register an earlier application in DAS. Furthermore, an application will not be registered in DAS until national security clearance is granted.

Note: For patent applications, the USPTO deposits only national patent applications in DAS and no PCT applications.
