

## RENEWAL OF THE INTERNATIONAL REGISTRATION

### IMPORTANT

We strongly recommend that you renew your international registration through [eHague](#).

If using form DM/4:

1. You can renew only **one** international registration **per form**.
2. Special note on the designation of the **United States of America (US)**: US national law provides for a single 15-year term of protection, counted from the date of grant of protection. If you wish to continue to benefit from centralized management of your international registration including the US, you must renew the designation of the US. While there is no renewal designation fee for the US, the basic fee applies.
3. Use the [Hague System Fee Calculator](#) to calculate the cost of renewing your international registration or consult [Hague System Fees and Payments](#).
4. All fields are **mandatory** unless indicated otherwise.
5. You must complete this form electronically; WIPO cannot accept handwritten forms.
