IMPORTANT

1. This form may only be used to request the renewal of a **single** international registration resulting from an international application governed exclusively or partly by the 1999 Act and/or the 1960 Act.
2. With respect **only** to Contracting Parties designated under the 1934 Act, the international registration cannot be renewed beyond the maximum duration of protection of 15 years.
