In accordance with Rule 24(5)(b), the above-mentioned irregularity(ies) should be remedied within a three-month time limit from the date of this notification (expiring on 14 September 2017), failing which the subsequent designation will be considered abandoned. In that case, any fees paid in respect of the subsequent designation will be reimbursed after deduction of an amount corresponding to one-half of the basic fee.
