- 2. Does your national legislation permit the cross-border exchange (i.e. exportation) of "accessible format copies", as defined in Article 2 b)1 MVT? If yes, under which conditions?

Section 54(5) of the Copyright Act allows, on a non-profit basis, the making of an accessible format copy in a physical form for the purpose of export, as well as the making available of an accessible format copy in an electronic form, for or to a foreign institution assisting persons with reading disabilities or a person with a reading disability who is not resident in Singapore. This is subject to the conditions in Section 54(6) of the Copyright Act: *

- The body administering the institution assisting persons with reading disabilities must comply with prescribed requirements for the purpose of ascertaining or verifying the identity of, and other information concerning, the foreign institution assisting persons with reading disabilities or the person with a reading disability who is not resident in Singapore.
- The body administering the institution assisting persons with reading disabilities must keep certain prescribed records as soon as practicable after the making or making available of the accessible format copy.

Section 54 applies only to literary, dramatic and artistic works. Section 115C extends its application (with the necessary modifications) to sound recordings and sound broadcasts.

3. Does your national legislation allow the importation of "accessible format copies", as defined in Article 2 b) $_2$ MVT? If yes, under which conditions?

Section 54(8) of the Copyright Act allows, on a non-profit basis, the importation of an accessible format copy in a physical form of a work that originated from a foreign institution assisting persons with reading disabilities. This is subject to the conditions in Section 54(10) of the Copyright Act: *

 The body administering the institution assisting persons with reading disabilities must have made a request to the foreign institution assisting persons with reading disabilities for the accessible format copy for use by a person with a reading disability.

- Such use must be for a permitted purpose, ie. for the purpose of research or study undertaken or to be undertaken by a person with a reading disability, or for the purpose of the person instructing himself/herself in any matter.
- The body administering the institution assisting persons with reading disabilities must keep certain prescribed records as soon as practicable after receiving the accessible format copy.
- The body administering the institution assisting persons with reading disabilities must be satisfied after reasonable investigation that no new accessible format copy of the relevant work that has been separately published and is in the same format as the copy requested for, can be obtained within a reasonable time at an ordinary commercial price.

Section 54 applies only to literary, dramatic and artistic works. Section 115C extends its application (with the necessary modifications) to sound recordings and sound broadcasts.

4. Does your national legislation provide a definition of "authorized entity", as defined in Article 2 c)3 MVT? If yes, please provide the reference.

While the Copyright Act does not contain a definition of "authorised entity" (as defined in Article 2(c) MVT), it provides that limitations and exceptions apply to any "body administering an institution assisting persons with reading disabilities". Under Section 7(1) of the Act read with Regulation 4 of the Copyright Regulations, an institution assisting persons with reading disabilities is defined as:

- an institution that has as its principal function, or one of its principal functions, the provision of works or other subject matter to persons with reading disabilities;
- that is formed, incorporated or established in Singapore; and
- that is declared under the Second Schedule of the Copyright Regulations to be such an institution.
