Jurisdiction - General Information

The Republic of Korea has been a Contracting Party to the Paris Convention since May 4, 1980. It has also been a Contracting Party to the Patent Cooperation Treaty (PCT) since August 10, 1984. In addition, it is a party to the Budapest Treaty on the International Recognition of the Deposit of Microorganisms for the Purposes of Patent Procedure.

Online Patent Register and Online Gazette

The Republic of Korea has an [Online Register](#) (KIPRIS) and an [Online Gazette](#).

Features and search functionalities

The online patent register has an **English** and **Korean interface**.

Through the patent register you can retrieve information on PCT **National Phase Entry**, **Legal Status**, **Fee Payment**, Patent Term Adjustments (an instrument of **Patent Term Extension**), and access the **Dossier/File Wrapper Information** and the **Full Publications**.

The patent register can also be searched by **PCT Application/Publication Number**, by **Applicant/Inventor Name**, and by **Priority Data**.

The online gazette is published daily in Korean and is searchable by date in HTML format. The current coverage is from 2016 to present.

Additional Information

Particularities of patent protection in the Republic of Korea

An instrument of **Patent Term Extension** (Patent Term Adjustment) for pharmaceutical products is available.

The normal patent term of protection of 20 years can be adjusted if the registration of a patent is delayed more than four years from the filing date of the application; or more than three years from the date of filing a request for examination.

From September 29, 2017, the "application date" of PCT national phase entries is the application date of the PCT application; prior to that it was the date of submission of the translation.

Search tips

To search the patent register for non-Korean language speakers, it is suggested to follow the explanations in English provided by the [European Patent Office](#).

To search by **PCT Application Number** use the format PCT/EP2009/000017.

The PCT **National Phase Entry** date is reported as "Application date" (INID code 21) in the bibliographic record, in the "Legal Status" or "Administrative" tabs as "Document according to the Article 203 of Patent Act" or indicated properly (as INID code 85) in the cover page of the publication, e.g. Korean publication number 10-2010-0111682 resulting from PCT/EP2009/000017.

Fee Payment information is available only for applications with the status "Registered" or "Ended", e.g., for application 10-1999-7008046, in the "Registr. Details" or "Administrative" tabs.

An example of **Legal Status** is "Rejected" for application 10-1998-0704043.

Public access to the **Dossier/File Wrapper Information** is possible through the 'Global Dossier' service integrated in Espacenet (including machine translation) for KR-A publications. **Dossier/File Wrapper Information** through the [online interface K-PION](#) is available for authorized patent offices only. The Global Dossier covers applications filed since January 1, 2000.
